Redlich and others signed sall April 13 newspaper no add vertisement condemning The House UnAmerican Activities Committee. Anothiceth signer was Waldo Frankobne of the original organizers of the fair play for Cuba comio mittee, which has been cited as a Communist front by the Senate Internal Security Subcommittee.

Other signers of the Abril 373 advertisement included persons who have invoked the protection of the Fifth Amendment rather than answer questions about ally Communist connections 1891-0

Redlich was attorney for Hale ry Magdoff, who invoked the Fifth Amendment May 31, 1961, when asked about his Communist ties. Magdoff was identified in July, 1948, as a Communist.
