BASIS FOR INQUIRY

A confidential source abroad has advised as follows:

OLTVEROS vaguely recalled that the buyer of this vehicle either resided or had his place of business in the Colonia Del Valle section of Mexico, D. F. He also recalled that this individual had a brother who claimed he was married to an American girl.

on April 17, 1964, a confidential source who has furnished reliable information in the past advised that it had been determined from observation that HORACIO DURAN NAVARRO, the husband of SILVIA/TIRADO DE DURAN (former Cuban Embassy employee in Mexico, D. F., who was contacted by IEE HARVEY employee in Mexico, D. On April 24, 1964, CLAUDIO OLIVEROS advised that he had learned from a former associate in the used car business in Mexico, D. F., that an automobile sales receipt still in the possession of the latter individual clearly shows that OLIVEROS sold a 1959 Renault, motor number 7444492, to a Mr. DURAN at Mexico, D. F., in 1961. OLIVEROS stated that this sales receipt was signed by DURAN but the signature was somewhat illegible and he was unable to read the full name. It was brought to the attention of OLIVEROS that records of the Mexican Federal Automobile Registration Bureau record the motor number of this 1959 Renault as No. 744492. OLIVEROS stated that he is certain that the motor number he provided is correct on the basis of the sales receipt which he had personally examined and added he is convinced that, this is the vehicle which was formerly the property of ARTURO GAONA ELIAS of Ciudad Obregon, Sonora, Mexico, which he, OLIVEROS, had purchased in 1961 in Ciudad Obregon.

On April 25, 1964, front-view and profile photographs of HORACIO DURAN NAVARRO were exhibited to PEDRO GUTIERREZ VALENCIA, who stated that the photographs of DURAN in no way resemble the unknown Cuban he observed on or about October 1, 1963, in the company of an American he thought to be OSWALD.

GUTIERREZ advised that he had not been able to devise any means whereby he might visit the Cuban Embassy in an effort



to identify the unknown Consular Section employee who was the subject of his credit inquiry on or about October 1, 1963, and, due to the extreme illness of his wife, he had found it necessary to spend most of his time at home caring for his wife. GUTIERREZ mentioned that he had continued to study the problem of how he might further substantiate his allegation that the American he observed at the Cuban Embassy was LEE HARVEY OSWALD, but he had been unable to devise any possible way of doing so.

On April 25, 1964, GUTTERREZ pointed out that the data he has previously provided has exhausted his means of substantiating his allegation.

ALKON explained that he maintains a contractual relation with HORACIO DURAN NAVARRO for the interior decoration of houses designed by ALKON and is well acquainted with his brother, RUBEN DURAN NAVARRO, as well as with one sister who is known to ALKON as "LIN."
