The requested item is a 40-page pamphlet by Corliss Lamont entitled "The Crime Against Cuba" (copyright 1961 by Basic Pamphlets). A <u>different</u> copy of this pamphlet has been reproduced as CE 3120 in the <u>Hearings Before</u> the <u>President's Commission on the Assassination of President Kennedy</u> (26 H 774-784).

A copy of SA Quigley's report of his interview with Oswald is pages 6 - 10 of the report of SA Milton R. Kaack, dated October 31, 1963, at New Orleans. The Kaack report bears file number NO 100-16601 and, with no attachments, forms Warren Commission Exhibit CE 826 (17 H 753-769).

It is noted that SA Quigley reported that Oswald made available a copy of the pamphlet "The Crime Against Cuba" (17 H 761). I have reason to believe that the material obtained from Oswald at that time was filed under the number 100-16601, presumably in New Orleans.

If your records indicate that the pamphlet I have requested (or a copy thereof) was furnished to the President's Commission on the Assassination, I would appreciate being advised of that fact, and being furnished any information (date of transmittal to the Commission, exhibit number, etc.) which would enable me to locate it in the Commission's files at the National Archives.
