c. Data from Transcripts of Radio Fransmissions by Dallas Area Law Enforcement Agencies and Related Investigation 1

On March 20, 1964, a transcript of all radio transmissions emanating from the Dallas County Sheriff's Office during the period from 12:20 P.M., November 22, 1963, to 6:00 P.M., November 24, 1963, relating to the assassination of President JOHN FITZGERALD KENNEDY, murder of Dallas Police Officer J. D. TIPPIT, investigation of said assassination and murder, and the security and movement of LEE HARVEY OSWALD to the Dallas County Jail reflected that between 1:34 P.M. and 1:49 P.M., all offices were alerted concerning a green and white 1957 Ford bearing Texas License DT 4857 with a white male as an occupant. This was indicated as being an anonymous tip. During this period, also broadcast was the fact that the individual in the green and white Ford bearing Texas License DT 4857 had been apprehended in Fort Worth, Texas.

Previous investigation in the case entitled, "ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY NOVEMBER 22, 1963, DALLAS, TEXAS" has established that DONALD WATNE HOUSE, 404 Lula Street, Ranger, Texas, arrived in Dallas, Texas, approximately 10:30 AM on November 22, 1963, and parked his car, a 1957 Ford, green and white, 1963 Texas License DT 4857 in an unrecalled parking lot on Commerce Street in Dallas.

As previously reported in the above-referred to investigation, HOUSE was interviewed at the Fort Worth Police Department on November 23, 103, at which time he advised that immediately after the Presidential parade he returned to his car and headed for Fort Worth, Texas. He denied having any firearms with him from the time he left his home at Ranger, Texas, at 8:00 AM on November 22, 1963, and denied any knowledge of the shooting of President KENNEDY.

On March 20, 1964, Inspector J. HERBERT SAWYER, Dallas Police Department, made available transcripts of all radio transmissions from Channel 1 and Channel 2, the Dallas Police radio station, KKB-364, covering the period 12:20 P.M., November 22, 1963, to 6:00 P.M., November 24, 1963, as they relate to the assassination of President KENNEDY, the murder of Dallas Police officer J. D. TIPPIT, investigations of said assassination and murder, and the security and movement of LEE HARVEY OSWALD to the Dallas County Jail.

A review of such radio transmissions reflects that on November 22, 1963, immediately after the shooting of Dallas Police officer J. D. TIPPIT, there was a radio transmission to the effect that a white station wagon, believed to be bearing Texas License PE 3435, occupied by two white males, had left a service station in the 400 block of East Jefferson Street, Dallas, Texas, going east on Davis Street, in which vehicle there was believed to have been a shotgun or rifle lying in the back seat. A subsequent radio transmission indicated that 1963 Texas License PE 3435 was for a 1961 Falcon four-door.

Also reflected in the transcript was transmission to the effect that a person at 5818 Belmont, Dallas, Texas, had alighted from a car with a rifle at this address at 2:19 P.M. on November 22, 1963. Thereafter, another transmission reflected that a light green car bearing 1963 Texas License RB 8950 and a light-colored Falcon bearing 1963 Texas License NX 3171 were parked at the 5818 Belmont Street address.

Also, on November 22, 1963, at 2:33 P.M. there was a radio transmission instructing that the driver of a 1957 Chevrolet sedan bearing License NA 4445 should be picked up for investigation and that this individual was last seen in the vicinity of 10th and Jefferson Streets, Dallas, Texas.

CICERO E. STOREY, 705 North Dallas, Ennis, Texas, advised he is the owner of a 1961 Falcon Station Wagon which formerly carried Texas License PE 3435. He stated he formerly resided at 5317 Goodman Street and until March 18, 1964, at 209 North Brighton, Dallas.

STOREY advised that on November 22, 1963, he was home in bed asleep as he had worked the previous night and learned of the shooting of President KENNEDY through a telephone call from his wife who had taken their station wagon to work with her. He stated his wife was working at the Half Circle-S Drive-In at Singleton and Bernal Streets where she worked until 2:00 PM arriving home at approximately 3:00 PM. He stated to his knowledge his wife was in possession of the car from early morning hours of November 22, 1963, until she arrived home at 3:00 PM that date.

STOREY advised he was not acquainted with LEE HARVEY OSWALD and that he has never carried a firearm in this automobile.

Mrs. WAOMI STOREY, 705 North Dallas, Ennis, Texas, advised she and her husband own a 1961 Falcon Station Wagon which in 1963 pore Texas License PE 3435. She advised they formerly resided at 5317 Goodman Street, Dallas, and until March 18, 1964, resided at 209 North Brighton Street, Dallas.

Mrs. STOREY advised that on November 22, 1963, she drove this automobile to work at the Half Circle-S Drive-In located at Singleton and Bernal Streets, Dallas, and parked the car at that location from 7:00 AM until 2:00 PM. She pointed cut that during this period of time no one else drove this automobile and that when she arrived how at approximately 3:00 PM, she parked the car at her residence and it was utilized no more on that date.

Mrs. STOREY advised that neither she nor her husband own any firearms and that to her knowledge, no firearms of any type have ever been transported in this automobile. Mrs. STOREY concluded by stating that LEE HARVEY OSWALD was not known to her.

Mr. FRANK LAURANT, 5818 Belmont, Dallas, Texas, advised that on November 22, 1963, during the early afternoon hours, he observed a young white boy about 22 or 23 years of age go into the driveway directly across the street from him, 5819 Belmont, Dallas, Texas, remove a rifle or shotgun from the automobile and enter this residence. He stated this individual was not known to him and in view of the fact he had heard over the radio that President KENNEDY had been assassinated earlier that day, immediately notified the Dallas Police Department. He stated shortly after calling the Dallas Police Department, squad car bearing two officers interviewed the young man in the front yard of 5819 Belmont for a period of about 20 minutes and thereafter left the residence taking no apparent action against the boy.

LAURANT advised 5819 Belmont Street is a residence type building converted into apartments and he knows no one residing in the building. He pointed out he had no reason whatsoever to suspect the young boy to have anything to do with the assassination of President KENNEDY other than the fact he had a firearm in his possession and that is the reason he had notified the Dallas Police Department.

LUCY JOHNSON, 5804 Belmont Street, Dallas, Texas, advised that on November 22, 1963, officers of the Dallas Police Department came to her residence to use her telephone and report to their headquarters that they had just checked out one of the tenants at 5819 Belmont and determined that this person was not connected in any way with the assassination of President KENNEDY. She stated she mentioned to the officers that 5819 Belmont is a private residence converted into apartments and that she manages all of the apartments at that address. According to Mrs. JOHNSON, the officers told her that one of her tenants, WAYNE MARRS, had been reported to have had a rifle or shotgun in his possession, but that they had established that although he did have a rifle in his automobile, such was in his legal possession and at the time the President was assassinated, MARRS had been in Corsicana, Texas, where he had borrowed the rifle to go hunting.

Mrs. JOHNSON advised MARRS has since moved and that she does not know his current address, place of employment, or any background information concerning him.

GEORGE THOMAS HUNSAKER, Box 199, Seagoville, Texas, advised he is the owner of a 1955 Oldsmobile, two-tone green and white, which formerly bore 1963 Texas License RB8950. He stated that on or about November 15, 1964, he borrowed a foreign mail. 303 rifle from a friend of his by the name of WAYNE MARRS, a resident of Corsicana, Texas, and a mechanic at the Clarence Talley Volkswagen Company, 710 Nofth Pearl, Dallas, Texas.

HUNSAKER advised after borrowing the rifle from MARRS, he and his cousin, ROY LANE, Seagoville, Texas, went into the vicinity of Crockett, Texas, to hunt deer returning two days later as his cousin was needed at home. He advised he immediately returned by himself to the vicinity of Crockett, Texas, and hunted until November 21, 1964, when he returned home which at that time was at 4403 Gaston Avenue, Dallas, Texas. He pointed out the following day, sometime shortly before noon, he drove to the residence of MARRS at 5819 Belmont, Dallas, to return the rifle and finding MARRS not at home gave the rifle to his wife, PAULA MARRS. He continued that while he and PAULA were drinking coffee at the MARKS residence, two officers from the Dallas Police Department came to the residence stating they desired to check the rifle and question him concerning his whereabouts in view of the fact President JOHN FITZGERALD KENNEDY had been assassinated on that date. He advised they questioned him concerning his background and hunting trip and thereafter returned the rifle to him.

HUNSAKER viewed a photograph of LEE HARVEY OSWALD and advised that although he is familiar with the photograph from viewing OSWALD numerous times in the newspapers and on television, he has never seen him in person and is not acquainted with him.

Through interview and observation, the following descriptive data of HUNSAKER was obtained:

Mr. CEGIL U. FETTY, 11299 Tantor Road, Dallas, advised that he is employed by the City of Dallas, Sanitation Department, as a truck driver and on November 22, 1963, owned a 1957 Chevrolet, which bore 1963 Texas License NA4445.

He stated that on November 22, 1963, he drove the above car to work and parked it on Shore Crest Drive and Denton Drive which is the location of a Sanitation Department Utility Station. He stated his car was parked at this location the entire day and that he spent most of the day working in his truck in the vicinity of Maple and Cedar Springs in Dallas. He stated at the time the President was assassinated, he was in his truck and not in the vicinity of the Texas School Boo Depository Building.

He stated at one time there might have been a pick-up out on his automobile as it was stolen during the summer of 1963, but recovered same day it was stolen. He stated when he recovered it, he notified the Dallas Police Department, but has no other reason as to why a pick-up should have been out on his automobile.
