

In regard to the foregoing information furnished by Mr. and Mrs. JOHN WESLEY PENNINGTON, the following is noted:

Previous investigation has determined that LEE HARVEY OSWALD was reportedly wearing a light gray cotton jacket with a full-length zipper in the front between the time he left his rooming house at 1026 North Beckley, around 12:55 p.m., November 22, 1963, until shortly after he shot Dallas Police Officer J. D. TIPPIT at approximately 1:17 p.m., November 22, 1963. (The PENNINGTONS described the jacket as definitely medium brown with dark brown vertical stripes.)

The movements of LEE HARVEY OSWALD from the time of the shooting of President KENNEDY at approximately 12:34 p.m., November 22, 1963, until his arrest at the Texas Theater at about 2:00 p.m., November 22, 1963, have been accounted for as follows:

(1) President KENNEDY was shot at approximately 12:34 p.m. in downtown Dallas.

(2) OSWALD boarded a bus in downtown Dallas near his place of employment, but left same shortly thereafter, about 12:40 p.m., due to traffic congestion.

(3) OSWALD boarded a taxicab at the Greyhound Bus Station in downtown Dallas at about 12:45 p.m.

(4) OSWALD got out of the taxicab on North Beckley and walked north toward his rooming house at 1026 North Beckley, Oak Cliff section of Dallas, at about 12:55 p.m.

(5) OSWALD entered the rooming house about 1:00 p.m. and left shortly thereafter.

(6) OSWALD is accused of shooting officer J. D. TIPPIT at 1:17 p.m.

(7) OSWALD was arrested by local Dallas Police inside the Texas Theatre at 2:00 p.m.

It is noted that the PENNINGTONS advised they are not sure of the time they were in the laundromat, but after they returned to their residence a few blocks from the laundromat, they shortly thereafter received a telephone call from their daughter in Phoenix, Arizona, advising them of the assassination of President KENNEDY, which was unknown to them at that time. The PENNINGTONS believe they were in the laundromat sometime between 12:00 noon and 1:00 p.m., Friday, November 22, 1963.

It is further recalled that the PENNINGTONS stated that the individual they saw and that they believe was OSWALD drove up to the laundromat, and then left, after making a telephone call, walking south on North Clinton Street. Extensive investigation regarding OSWALD has not revealed that he owned a motor vehicle or even knew how to drive a car.

The distance between the Tidy Lady Laundrette, 1227 Davis Street, and the Texas Theatre is a little over one mile.
