Sylvia Dear -

At last a breaking spell, in the frenzied parisian tempo, descends momentarily so that I can at least write these few lines to you. First, let me say again how profoundly rewarding the visit with you in New York was for me, for many reasons - for I found not only a dedicated co-worker (some-
how the word collaborator still has odious implications!) but, more importantly, a friend. I was truly touched by your hospitality, interest and attention in the midst of your staggeringly busy schedule. Secondly, I want to keep you posted on what has happened up to date, although - in that regard, there is nothing too startling. There are only two pertinent, albeit minor, events to report since my arrival here in Paris. 1.) Tom Buchanan calls a day or so after my arrival & took me to lunch. He's quite a charming guy with a nice, easy manner & a pleasing sense of humor. We talked (I'm afraid I did most of the talking) for about 3 hours - but I can't say either of us

accomplished anything. He works, as you know, at an electronic firm & on the side he continues to write. He has just about completed a novel which sounds to me at least as if it's going to be more commercial than anything else - all the usual conventional parts of sex, mystery & espionage which seem to be the required ingredients of any sale-able current publication (said she pointedly & bitterly). He was quite fascinated by what I had to say about you & our meeting + Epstein et al - & he's of course, still very interested in the case but I guess he's gone about as far as he can go now - with it - except for an article, I believe. I asked him to come over to the hotel so I could show him the break-down of the photograph with the rifle & some of my exhibits, etc. & he said he would - but I haven't heard from him since, so at this point, I don't know if I shall see him again or not.

2). I had a letter from Sawage resulting directly from your having telephoned him.
