

QUESTION: WAS A THIRD PERSON WOUNDED IN DEALEY PLAZA ON NOVEMBER 22, 1963? (I don't consider Tague "wounded")

Clue: See Bothan photo of knoll minutes after shooting showing a black woman running with a child or having just been handed the child by a man rushing to her. Can't tell the age of the child from the photo.

Clue: Think she may be same woman shown in Betzner photo at right on North side of Elm carrying bag. ~~Child could be with man standing behind her with a hat.~~ This would put her very near where Eugene P. Aldredge thought he saw a bullet scar the sidewalk.

Clue: FBI report of September 30, 1964 states in the area of the second light post, approximately thirty-three feet east of the post, in the sixth large cement square, four feet from the street curb and six feet from the parkside curb is a...dug out scar...which would have been made by some...projectile.

Clue: Pool of blood was found on the walk leading up to the shelter immediately behind this black family... OR ON WALK MAN AND CHILD ARE ON, IT'S NOT CLEAR. MALCOLM COUCH TESTIMONY

Clue: See the attached statements by nurses at Parkland:

Clue: See Jackson testimony that follows:

LEADS TO CHECK:

1. Locate this couple and boy named Ronald Fuller and
2. Show them photos
3. Interview nurses to see if this could be gunshot. It appears that mother may have been taken aside at Parkland and cautioned to keep quiet about this, since if she were standing as shown in the Betzner photo she would have been "out of the line of fire" (officially). I doubt if a shot from the TSBP would fall short and hit the north sidewalk.
4. How the baby was transported to the hospital and do hospital records list address of this child.
5. Police broadcasts - check to see if this is mentioned.

About this time, a colored lady in hysterics came in with a child apparently 3 to 5 years old in her arms. The child had blood on its face and blood was streaked down the right side of the face. It appeared to have blood from the corner of the mouth. An orderly and an aide were standing by nearby and one of them took the child and we helped the mother to sit down at the chair at the Triage Desk.

R. G. HOLCOMB - PRICE EXHIBIT, page 250

During the time I remained at the Triage Desk several patients arrived. Mrs. Lozano directed them, I believe, to the x-ray waiting area. One patient, a child about 3 years old, arrived in his mothers arms. He was bleeding profusely.

SHIRLEY RANDALL - E.R. AIDE, Page 219

Just as I got out there, a lady brought her little boy in who had been cut on the jaw. Blood was all over her and the child. She started to faint, and the Triage orderly grabbed the child and I watch her while I went right across from the desk to the blood bank and got some ammonia for the mother to smell; she got alright then. I led her to the emergency room and found a booth in medicine for the doctor to suture the baby. That is when he told me and some more aides that the President was dead.

BERTHA LOZANO, page 213 PRICE EXHIBIT

At this time, a crying mother rushed in with her bleeding child in her arms and the orderly rushed the child to major surgery.

ERA LUMPKIN - AIDE, page 208 PRICE EXHIBIT

Some one brought in this baby that was all bloody. Mrs. Nelson said, "Rosa, you and Era take care of that baby." So Rosa took the baby and put him on a cart. I spotted the cut on the cheek. I asked about the mother. No one knew where she was. I went out to the desk and was told the mother was on her way inside the emergency room. When I got back into the emergency room, the mother had arrived. A doctor said "Put the child in a booth." So we put the child in a booth. The child was crying so loud, some one asked us to carry the baby in major medicine and set up a booth for suturing. After we got the baby around to major medicine and in a booth, the mother of the child asked how was the President. The doctor said, "He is dead".

This testimony in Volume 2 may have something to do with this child: Mr. Jackson: As we did turn the corner our driver speeded up and we went by the scene pretty fast and I do recall this Negro family covering up their child on the grass, and I, as we passed them, they were just getting up and he had the child in his arms as we passed them, they were just getting up and he had the child in his arms and the child looked limp and I didn't know whether the child was shot or not.

EYEWITNESS ACCOUNT BY DALLAS TIMES HERALD PHOTOGRAPHER

"...We were beginning to turn the corner. He (the gunman) had about a 45 degree angle from the building to the President's car.

I looked to my left and I could see both cars speeding off, the President's car and the car behind him carrying the vice-President. They disappeared under the underpass.

Then I could see a colored family covering up their child on the grass. A policeman was down on his knee. I could not tell if he were hit. THEN I thought the child was dead or something. Then the Negro parents picked ~~the~~ up the boy and ran."
