Personnel at the Military Personnel Records Center, St. Louis, Missouri, made available a record for EARL SHELDEN PERRY, Serial Number 55438769, which indicated he was inducted into the U. S. Army on April 21, 1954, and entered on active duty the same date at Denver, Colorado. He was honorably released from active duty January 23, 1956, as a Specialist Third Class at Fort Bliss, Texas, to attend school and was transferred to the U. S. Army Reserve to complete his military obligation.

PERRY served in the U. S. Army Reserve, inactive status, from January 24, 1956, to April 20, 1962, at which time he received an honorable discharge.

PERRY's record contained a letter dated December 6, 1955, reflecting his acceptance to the University of Wyoming, Laramie, Wyoming.

PERRY's record reflected the dates and places of his assignments as follows:

April 21, 1954, to April 30, 1954 - 6023 SU, RC, Fort Ord, California.

May 1, 1954, to September 10, 1954 - HQ Battery, 51st FA Battalion, Sixth Infantry Regiment, Fort Ord, California.

September 11, 1954, to September 21, 1954 - En route to 59th AAA Battalion, Fort Bliss, Texas.

September 22, 1954, to November 23, 1954 - 59th AAF Battalion, Fort Bliss, Texas.

November 24, 1954, to date of release - HQ 4052 ND, SU, Fort Bliss, Texas.

PERRY's military occupation was shown as chaplain's assistant and his civilian occupation was reflected as student. He had no foreign service. He was awarded the National Defense Service Medal.

PERRY's Selective Service Number was reflected as 48133340, Board #13, Casper, Natrona, Wyoming. His date of birth was listed as March 17, 1933, at Casper, Wyoming. His address at the time of his release was shown as 632 South Grant Street, Casper, Wyoming.

The record indicates an Honorable Discharge Certificate was mailed to SP 4, EARL S. PERRY, #3 Wainwright, Laramie, Wyoming, and returned to the center as an incorrect address.

PERRY's record reflects he was qualified on May 29, 1954, for rifle, M-1.
