



J.C. Price who saw the assassination from the roof of the Terminal Annex building across Dealey Plaza said in an affadavit filed November 22, 1963.

"I saw one man run towards the passenger cars on the railroad siding after the volley of shots. This man had a white dress shirt, no tie, and khaki colored trousers. His hair appeared to be long and dark and his agility running could be about 25 years of age. He had something in his hand. I couldn't be sure but it may have been a head piece."

He later said: "the man was carrying something in his right hand" which "could have been a gun."

Two motorcade officers rushed up the Grassy Knoll after the shooting, apparently in pursuit of gunmen. The officers, Hargis and Haygood testified that they thought that was the direction from which shots had been fired.




FIGURE 1. Photo taken near grassy knoll, Dealey Plaza, Dallas, Texas, Nov. 22, 1963.




FIGURE 1-A. Closeup of unknown person in Dealey Plaza photo.



more than 40 people who were
directly, or indirectly connected with

18 "material witnesses," that is,
people who could have been called to

He ordered U.S. air support removed from the plan and insisted that only Cuban refugees could take part in the actual invasion. The C.I.A. believed the invasion would inspire a popular uprising among the Cuban people. Instead, the Cubans rallied to Castro and the invasion was a failure. The Cuban refugees blamed Kennedy for the failure even though air support twould not have altered the course of the battle.

One of the C.I.A. agents in a key position in the planning of the Bay of Pigs was E, Howard Hunt. The army officer who acted as liaison between the Kennedy White House and the C.I.A. was Major Alexander Haig. (Here is the relationship between Diem. Bay of Pigs, Kennedy assassination and Watergate—Ray Paimer.)

According to the official records, no members of the Secret Service were stationed in Dallas' Dealey Plaza on the day the President was shot. However, two men claiming to be Secret Service were present on the grassy knoll that day and were even wearing the small colored pins that identified them as such. (The color of the pins is changed daily...they were wearing the right color.) There were numerous other strangers about. William Allen, a photographer for the Black Star agency, snapped pictures left and right after the assasination. One of his photographs was Dallas policemen leading a man away from the grassy knoll. He was slim, with thinning hair, an angular face, a sharp pointed nose and a determined jaw. The photo is printed here. (Figs. 1 & 1a).

There is no official record of this man's presence in Dealey Plaza that day.



Luther King is shot down in Memphis. A few days later the F.B.I. announced that the name of the killer was Evic Starvo Galt and they released a drawing (Fig. 2) which was widely published. It was supposedly composed from the descriptions of the people who lived in the rooming house across from the motel balcony where King was shot. The sketch resembles almost exactly the man photographed in Dealey Plaza. It does not resemble James Earl Ray, who was later arrested and convicted of the crime. The rooming house witnesses agreed that the sharp-nosed man was the one who had rented a room. When they were later shown photographs of Ray they said he was not the man.

Apparently the man in Dealey Plaza had been directly involved in the King assassination. The name "Eric Starvo Galt" was from the name of a character in one of Ian Fleming's James Bond novels.

(6) Donald Freed, co-author of Executive Action, a novel of the assassination, told the Los Angeles Star, "The professionals in the Watergate... are tied to the CIA, Cuban politics, the Miami area, and assassination." He states there was a plot "to assassinate Castro before or coincident with the invasion," and this was called off by President Kennedy. Freed claims Hunt and Frank Sturgis, another Watergate defendant, were involved in this action, and two other assassination plots, in Haiti and Guatemala. Also, he states in a new book, Give Us This Day, that Hunt, Sturgis and Liddy "were in Mexico City in 1971 as part of an executive action to assassinate the president of Panama" but this was "called off and aborted".

Freed suggests the answer to a mystery of the Watergate hearings. Why did the White House order CIA officials to stop the FBI from investigating the laundering of funds through Mexico?
