Mr. Galt, who drove an automobile similar to the one believed used as a getaway car after Dr. King was shot by a sniper on April 4 in Memphis, has been the subject of a nationwide search by the Federal Bureau of Investigation.

Mr. Galt's car, a white Mustang, was impounded in Atlanta last Thursday by Federal agents.

Mr. <u>Cherpes</u>, who was asked by the F.B.I. not to discuss Mr. Galt, broke his silence today after reporters had repeatedly asked him questions over the weekend.

He said that last Tuesday Federal agents showed him some drawings of a man who bore a close resemblance to Mr. Galt.

In Louisiana today, state of-ficials said that Mr. Galt had never got a driver's license there, although he had said on his application for an Alabama license that he had got one in Louisiana in 1962.

Every development in the investigation thus far has suggested that Eric Starvo Galt is a fictitious name.
