A LETTER TO THE PRESIDENT

To Our Readers: Below is a letter we hope you will read and sign and mail to the President of the United States. —The Editor.

Dear Mr. President:

I am a regular reader of the National Tattler and a supporter of the publication's on-going investigation into the assassination of President John F. Kennedy.

As a former member of the Warren Commission, you recently reaffirmed the conclusion of that commission when you said, "We had no evidence of a conspiracy, foreign or domestic." You added, however, that "if the facts seem to justify it," Vice President Nelson Rockefeller's commission, presently probing the domestic activities of the Central Intelligence Agency, ought to reopen the Kennedy investigation.

Sir, I believe there are sufficient facts now available for the Rockefeller commission to examine. These facts include:

- Disclosure by the National Tattler that two men were offered \$25,000 to fly two men out of Dallas the day President Kennedy was killed and both the pilots believe the men who offered them the money were part of the conspiracy that did the shooting.
- The recently published book entitled "The Assassination Tapes," in which former CIA agent George O'Toole reveals that scientific tests show Lee Harvey Oswald was telling the truth when he said he didn't "shoot anybody, no, sir."
- The fact that 90 seconds after the shooting, Oswald was seen in the second-floor cafeteria of the Book Depository.
- That fire arms experts and pathologists agree that one single bullet could not have struck both President Kennedy and Gov. John Connally and remained in almost perfect condition.
- And, now, that a reputable author, W.R. Morris, whose "The Twelfth of August" became the motion picture "Walking Tall," has agreed to furnish the Rockefeller commission the name of the man who was Oswald's CIA contact. Morris has met the man, who has since retired from the CIA, and is aware of his whereabouts, according to the National TATTLER.

Those and numerous other facts are sufficient grounds for the Kennedy investigation to be reopened. I urge you to use your powers as the President of the United States to accomplish that end.
