

Supplementary Name Index

The Warren Report : Hearings and Exhibits

The supplementary name index provides the Commission Exhibit (CE) numbers for witnesses or other personalities who figure in the Warren Report or the Hearings. Volume XV of the Hearings contains a name index indicating the volume and page numbers for the testimony of witnesses, and the volume and page numbers for mentions of each name in the testimony of witnesses. The supplementary name index should therefore be used, as appropriate, as an addendum to the index in Volume XV.

The supplementary name index also indicates the references to a specific person who is not actually named in the testimony, where the actual identity is clear.
