Mr. Nixon was in Canada on a state visit April 13 to 15. Federal agents have determined that Mr. Bremer spent the nights of April 13 and 14 in the Lord Elgin Hotel in downtown Ottawa. He was identified in at least two pictures of crowds that gathered at scheduled appearances by the President, including one on April 15.

Secret Service agents, often posing as newsmen, routinely photograph the crowds that assemble at Presidential appearances to identify potential security risks.

The identification of Mr. Bremer was made from these films and others taken by local news media.


In addition to his Ottawa appearance, Federal sources said today that they had other evidence that Mr. Bremer had been stalking Mr. Nixon. The sources declined to describe the nature of this evidence, except to say that the suspect had "left tracks wherever he went," and that these tracks indicated an interest in the President and Senator Humphrey as well as Governor Wal-

## Trial Date Is Set

UPPER MARLBORO, Md., May 25 (Reuters)—Arther A. Marshall Jr., the state's attorney for Prince Georges County, announced today a tentative trial date of July 12 for Arthur H. Bremer. Mr. Bremer was indicted on Tuesday by the county grand jury on 24 counts.

In Baltimore, George Beall, United States Attorney for Maryland, said he had not been consulted by Mr. Marshall on the setting of a trial date on the state charges. However, Mr. Beall added, the action does not interfere with the Federal case. A trial date on the Federal charges has not been set.
