

A. Biographical Sketches of Senior Staff Members

ADAMS, Francis W. H. - New York, New York

Born in Mt. Vernon, New York in 1904, Mr. Adams studied at Williams College and received his law degree from Fordham in 1928.

After being admitted to the New York Bar, Mr. Adams became associated with the law firm of O'Brien, Boardman, Conboy, Memhard & Early in New York City until 1934, when he joined the United States Attorney's office in the Southern District of New York. He served in the United States Attorney's office as Chief Assistant United States Attorney in 1934 and Special Assistant to the United States Attorney General in 1935.

After his service in the United States Attorney's office Mr. Adams returned to private practice where he has remained active in the litigation of important civil and criminal cases. He is currently a member of the law firm of Satterlee, Warfield & Stephens with offices in New York and Washington, D. C. Mr. Adams has returned to public service on a number of occasions over the past 30 years, most notably during the war when he served as arbitrator for the War Labor Board in a number of labor disputes of national importance and during 1954 and 1955 when he served as Police Commissioner of New York City.

Mr. Adams is a member of the American Bar Association, the New York Lawyers Association, New York State Bar Association and the American College of Trial Lawyers. During 1952-54 he served as Vice President of the Bar of the City of New York. He is a member of the Board of Directors of the following organizations: National Recreation Association, American Irish Historical Society, Lincoln Hall, and the Police Athletic League.

BALL, Joseph A. - Los Angeles, California

Born in Stuart, Iowa in 1902, Mr. Ball studied at Creighton University, in Omaha, Nebraska, and received his law degree from the University of Southern California in 1927.

Mr. Ball is a member of the firm of Ball, Hunt and Kart with offices in Long Beach and Santa Ana, California. Mr. Ball is one of the nation's most distinguished practitioners in the criminal law field as well as a leading figure in state and federal

efforts to improve the administration of criminal justice. Mr. Ball is currently serving on the Judicial Conference Advisory Committee on the Federal Rules of Criminal Procedure and on the Commission to Revise Constitution of California. He is also a Professor at the University of Southern California Law School where he teaches a course in Criminal Law and Procedure. During 1955-56 and 1960-63 Mr. Ball served as a member of the California Law Revision Commission.

Mr. Ball is a member of the Long Beach Bar Association, Los Angeles Bar Association, State Bar of California and the American Bar Association. During 1956-57 he served as President of the State Bar of California and during 1960-61 he served as Chairman of the National Conference of Bar Presidents. He is a member of the California Jury Instructions - Criminal Committee and served on the Board of Regents of the American College of Trial Lawyers from 1952-55.

COLEMAN, William T. Jr. - Philadelphia, Pennsylvania

Mr. Coleman, age 43, is a member of the Philadelphia law firm of Dilworth, Paxson, Kalish, Kohn & Dilks.

Mr. Coleman was born in Germantown, Pennsylvania, graduated from the University of Pennsylvania in 1941 summa cum laude and received his law degree from Harvard Law School magna cum laude in 1946. He was an editor of the Harvard Law Review, and subsequently served as law clerk to Mr. Justice Felix Frankfurter during 1948-49.

Mr. Coleman was associated with Paul, Weiss, Rifkind, Wharton & Garrison of New York City from 1949 until he joined the Philadelphia firm in 1952. He has been a partner in the firm since 1956. Mr. Coleman is active as a trial and appellate lawyer in federal and state courts in business, corporate and natural gas litigation. He has served as special counsel for the City of Philadelphia on two separate occasions involving important transportation negotiations.

Mr. Coleman was a member of President Eisenhower's Committee on Government Employment Policy and is currently a consultant to the United States Arms Control and Disarmament Agency. He has served as a member and director of many important state and city civic organizations. Among other organizations, Mr. Coleman is currently a director of the Legal Aid Society of Philadelphia and a director of the Citizens' Committee on Public Education in Philadelphia. He is a member of the American, Pennsylvania and

Philadelphia Bar Associations, and currently is chairman of the Judiciary Committee of the Philadelphia Bar Association.

JENNER, Albert E. Jr. - Chicago, Illinois

Mr. Jenner received his law degree from the University of Illinois in 1930 and has been a member of the law firm of Thompson, Raymond, Mayer and Jenner in Chicago since 1933. Mr. Jenner engages in a general practice with particular attention to civil and criminal litigation in the state and federal courts throughout the United States.

Mr. Jenner is presently Vice Chairman of the Joint Committee on the Administration of Justice in the United States, whose Chairman is Mr. Justice Tom Clark. He has been a member since 1960 of the United States Judicial Conference Advisory Committee on Federal Civil Rules and a member of the Permanent Editorial Board of the American Law Institute. He currently serves as Chairman of the Illinois Uniform State Laws Commission and as a member of the National Conference of Commissioners on Uniform State Laws. Over the years he has given substantial service to various committees of the Illinois and Chicago Bar Associations that brought about the adoption in 1962 of a new judicial article to the Illinois Constitution which went into effect the first of this year.

In the criminal law field Mr. Jenner has served as Chairman of the Joint Committee of Chicago and Illinois State Bar Associations that drafted Illinois Post-Conviction Hearing Act of 1949 and Rules of Illinois Supreme Court regarding arraignments of defendants in criminal cases. He was co-draftsman of the Illinois Criminal Code in 1935 and has served as defense counsel in recent years in many important criminal prosecutions.

Mr. Jenner was Special Assistant Attorney General of Illinois during 1956 and 1957 to head up the investigation of frauds, embezzlement and fiscal scandals and mismanagement in the office of the Auditor of Public Accounts of Illinois. Mr. Jenner's investigation resulted in the imprisonment of the Auditor and others in his office for criminal conduct and produced major legislative and administrative reforms.

In addition to his many other activities, Mr. Jenner has served as Professor of Law at Northwestern University School of Law during 1952-53 and as litigation counsel of the University of Illinois. He organized and conducted the National Conference of the American Bar Association, the American Judicature Society and the Institute of

Judicial Administration on court reorganization and judicial selection and tenure in 1959. He is author and co-author of standard legal texts on Illinois practice, pleading and procedure and has contributed to various law journals.

He is a member of the National Conference of Bar Association Presidents (President 1952-53); American College of Trial Lawyers (President 1958); American Judicature Society (President 1958); Illinois State Bar Association (President 1949-50); the Illinois Society of Trial Lawyers; and the American Bar Association, where he is a member of several committees dealing with federal and state judicial reorganization and legal procedure.

B. Biographical Sketches of Junior Staff Members

BELIN, David W. - Des Moines, Iowa (Age: 35)

Mr. Belin attended the University of Michigan from 1948 to 1954, obtaining a Bachelor of Arts degree, a Master of Business Administration degree and the degree of Juris Doctor. At the University of Michigan Law School Mr. Belin was an Associate Editor of the Michigan Law Review and was one of the recipients of the Henry M. Bates Memorial Award made annually to the two most outstanding seniors at the University of Michigan Law School. Mr. Belin is a member of Phi Beta Kappa and the Order of the Coif.

After graduation Mr. Belin joined his present firm, Herrick, Langdon, Sandblom & Belin of Des Moines, Iowa, where he has been a partner since January 1955. The firm engages in a general practice and Mr. Belin has participated in a substantial amount of trial and appellate work since 1954.

Mr. Belin is very active in Des Moines civic affairs and professional associations. He served on the Polk County Republican Central Committee in 1956 and as a consultant to the Republican candidate for governor in 1960.

GRIFFIN, Burt W. - Cleveland, Ohio (Age: 31)

Mr. Griffin received his undergraduate education at Amherst College, where he received a Bachelor of Arts degree magna cum laude in 1954. After two years in military service, Mr. Griffin went to Yale Law School, where he received his LLB in 1959. During his law school years, Mr. Griffin specialized in the criminal law field and served as Note and Comment Editor for the Yale Law Journal. After graduation from law school Mr. Griffin served as law clerk to Judge George T. Washington of the United States Court of Appeals for the District of Columbia Circuit.

In 1960 Mr. Griffin returned to Cleveland, Ohio, where he served as an Assistant United States Attorney for two years. During these two years Mr. Griffin tried a substantial number of significant criminal cases, including a counterfeiting conspiracy involving 18 individual defendants. Since October of 1962, Mr. Griffin has been associated with the law firm of McDonald, Hopkins, & Hardy in Cleveland specializing in the trial of civil and criminal cases.

Mr. Griffin has served as Director of the Cleveland Chapter of the Federal Bar Association, has been active on several committees of the Cleveland Bar Association and is a member of the Cleveland Academy of Trial Attorneys.

SLAWSON, W. David - Denver, Colorado (Age: 32)

Born in Grand Rapids, Michigan, Mr. Slawson received his Bachelor of Arts degree summa cum laude from Amherst College in 1953, where he majored in mathematics and physics. Mr. Slawson was class valedictorian and president of the student government at Amherst. During 1954 Mr. Slawson studied for a Master of Arts degree at Princeton University under a fellowship from the National Science Foundation.

After two years in military service, Mr. Slawson went to Harvard Law School, where he received his degree magna cum laude in 1959. He served as one of the two Note Editors of Volume 72 of the Harvard Law Review. After graduation Mr. Slawson became associated with Davis, Graham and Stubbs in Denver, and has worked continuously with that firm, becoming a partner the first of this year. During his private practice, Mr. Slawson has concentrated on corporation and antitrust law.

Mr. Slawson is a member of the Colorado Bar Association's Statutory Revision Committee. He served as President of the Denver Young Democrats in 1960 and was an unsuccessful candidate for the House of Representatives of the Colorado General Assembly on the Democratic ticket in 1962.

SPECTER, Arlen - Philadelphia, Pennsylvania (Age: 33)

Mr. Specter received his undergraduate education at the University of Pennsylvania, where he received a Bachelor of Arts degree in 1951 and was a member of Phi Beta Kappa. After two years in the United States Air Force as a First Lieutenant in the Office of Special Investigations, Mr. Specter enrolled in the Yale Law School. He received his LLB in 1956 and was an Editor of the Yale Law Journal.

After his graduation from law school Mr. Specter became associated with the law firm of Barnes, Dechert, Price, Myers & Rhoads in Philadelphia. At that firm he engaged in a general practice with emphasis on litigation. In 1959 Mr. Specter joined the Office of the District Attorney in Philadelphia.

Since 1959 Mr. Specter has argued more than 40 appellate cases and has tried in excess of 100 cases ranging from minor matters to homicide cases. One of his most extensive trial assignments was the successful prosecution after a ten-week trial of six Teamster officials for conspiracy to cheat and defraud the union. As Chief of the Litigation Division of the District Attorney's office, Mr. Specter now spends a significant part of his time supervising the trials and appeals being conducted by other assistants in the office.

Mr. Specter currently serves as Chairman of the Criminal Law Committee of the Philadelphia Bar Association.

STERN, Samuel A. - Washington, D. C. (Age: 34)

Mr. Stern attended the University of Pennsylvania where he received his Bachelor of Arts degree in 1949 with major honors in Economics. He graduated magna cum laude from the Harvard Law School in 1952, where he served as Developments Editor for Volume 65 of the Harvard Law Review. After graduation from law school Mr. Stern went on active duty as a Lieutenant in the United States Air Force and served for two years at Wright-Patterson Air Force Base in Ohio.

Prior to entering private practice in Washington, D. C. Mr. Stern served during 1954-55 as law clerk to Chief Judge Calvert Magruder of the United States Court of Appeals for the First Circuit, and served during the following year as law clerk to Mr. Chief Justice Earl Warren. In 1956 Mr. Stern became associated with Cox, Langford, Stoddard & Cutler in Washington, D. C. and in 1962 became a partner in the newly-formed firm of Wilmer, Cutler and Pickering. During his years of private practice Mr. Stern has had considerable experience in the preparation and trial of major law suits, and has participated in many administrative proceedings before various agencies of the Government.
