De stated that on November $2 \%$ 2963, he skipped school and at approximatsly 22.15 . 2.0 , he was standing on the comer of Elm Street, facing the Texas school Boor Depository (TSBD) building, waiting for the president bal motorcade to pass. Fe said that he glanced at the menD building and noticed what appeared to be a meta 2 we attending out of mas he believes is the fief flex winder on the southeast aide of the SGBD butiding. ye seta to this rod at that particular sire, and shorty thereafter: the Presidential motorcade passed hims he waved to the president and the president waved back.

He said after the President's car started down the hill, he heard what he thought vas a cur backeixe and he looked around and ale glanced sis the spit building, and on the fifth floor where he hat seen whet he thought to be a metal rod, ha noticed a rifle th the window and gev che second and third shots fired. Fe stated he saw a man's hard on mas appeared to we the trigger housing and he could also see bald spot on the mans hegdo He stated he did not see the face of fits indivisugl and could not identify him. He said he was sure 5 his man was white, because his hand extended outside che window on the title.

He stated he also heard wat he believes was a fourth shot, and that the irsiotuud in the window after fixing the fourth shot, began losing around and he (EULAS\} ~ at this time hid behind a concrete partition. Be said he sam this individual withdraw the rifts and step back in the window.

EUINS stated he told a police officer about seeing the rifle and the shots and that the police ofricer thereafter entered the TSBD bullaing, and he was taken to the Dallas County Sheriff's cefice whexe he furmished a signed statement to Detective Jones or JOHNSON. He scated he remained at the Sheriff's ceflce from shortly after the President was shot until appramately 8 Po that night.

EUTNS advised he could not distinguish the features of the individual standing at the window, and as he had previously stated. he only saw his hand and a bald spot on his head.

He was unable to furnish ady additional information concerning the assassinasion os president JOGA PITZGERALD KENNEDY, on November 22, 1963.
