Page 7 of the aforementioned address book of LEE HARVEY OSUALD contained phone number RI. 2-6519 as the home phone number of Mrs. M. OSUALD. Local crisscross reflects RI. 2-6519 to be registered to Contractors Iron and Steel, 2720 Sylvan, Dallas, Texas. It is to be noted that LI. 2-6519 was the home phone number of Mrs. M. OSUALD in Vernon, Texas, and, in all probability, was erroneously listed by LEE HARVEY OSUALD in his address book.

This name does not appear in the last two telephone directories of Fort Worth, and he is not known at WBAP, Fort Worth. P. W. TAYLOR, Sheriff, Crowell, Texas, on December 23, 1963, advised that telephone number 684-3271 was listed in the name of Mrs. J. S. LONG, Crowell, Texas.

(It is noted that previous interviews with JOE LONG, Crowell, Texas, reflects that Mrs. MARGUERITE OSWALD worked for him taking care of his invalid mother, Mrs. J. S. LONG, for several weeks in 1962 and lived at his mother's home on Donnell Strest.)

JIMMIE LANE, Shipman Clinic, Vernon, Texas, on December 23, 1963, advised that the Vernon Convalescent Home, 2103
Marshall, Vernon, Texas, whose phone number was LI 2-2212, was operated as a partnership by a Mrs. WALL and her son-in-law, CHARLES NEIMAN until about August or September, 1962, at which time they sold to the Taylor Rest Home which has the same number. He added Mrs. WALL did not reside in Vernon and that her son-in-law, CHARLES NEIMAN, operated and managed the Vernon Convalescent Home. He added NEIMAN now resides at 123 San Miguel Drive, Arcadia, California. He added that Mrs. MARGUERITE OSWALD had worked for Mr. NEIMAN at the Vernon Convalescent Home for a short time in 1962 until NEIMAN let her go.
