The following investigation was conducted on November 29, 1963, by HENRY J. OLIVER and LOUIS M. KELLEY:

W. W. GEORGE, 6769 InVerness, Dallas, Texas, furnished the following information concerning LEE HARVEY OSWALD:

OSWALD and his family resided in the upstairs apartment at 214 West Neeley Street, Dallas, Texas, from about March 1963 until May 1, 1963. GEORGE stated he is the owner of this house and the upstairs apartment is 214 while the lower floor is 212 Neeley.

212 West Neeley was occupied from February 16, 1963 to May 1, 1963 by GEORGE B. GRAY and his wife. He believed GRAY was employed by Texas Power and Light Co. and his wife by Ward's, but stated he believed they had left Dallas and moved to Arlington, Texas when they moved away from 212 Neeley.

GEORGE stated he had no idea how to locate the GRAYS at the present time and also, that there are no other houses facing on Neeley Street in the block where this residence is located.

Mrs. W. G. PAIE, Apt. 1, 629 Elsbath Street, Dallas, Texas, advised on November 29, 1963 that she has only resided at this address for three weeks and does not know OSWALD. She advised that 214 West Neeley is behind her address and the only apartment in her building near the Neeley address is occupied by Mr. and Mrs. CARL OWENS, who have only resided at this address one week.

Mr. and Mrs. MARVIN FRIDDLE, 702 North Madison, Dallas, Texas, advised on November 29, 1963 that 214 West Neeley is around the corner and across the street from their home. They do not know OSWALD and cannot furnish any information concerning him. They do know that a young man, his wife and two small children resided at the upstairs apartment at 214 West Neeley for a very short time around April and May of 1963. The only reason they know this was because they would see him, his wife and children around this house and on the upstairs balcony. They were unable to furnish any information concerning

the activities or associates of OSWALD and his wife and did not believe anyone else in the neighborhood would be able to since the house where OSWALD resided sits by itself on West Neeley.

Mrs. NELL FRICK, 630 Madison, Dallas, Texas, advised on November 29, 1963 that she and her husband have resided at this address for about one month. 214 West Neeley is located behind the house where she resides and she was unable to furnish any information concerning OSWALD, his associates or activities.

Mr. W. D. ELLIS, foreman, Davey Tree Expert Co., 605 North Collins, Arlington, Texas, advised on November 29, 1963 that GEORGE B. GRAY left his employment with this company about July 1, 1963. His last check was mailed to him on July 3, 1963 at Route 2, Box 129, Ragland, Alabama. This is the only address he has for GRAY. ELLIS stated the application for employment for GRAY giving any background information available would be maintained at the home office of the company located at Kent, Ohio.
