The following investigation was conducted by
SA RONALD E. BRINKLEY at Dallas, Texas:

Previous investigation has reflected that one of the payroll checks payable to LEE OSWALD while employed by Jaggars-Chiles-Stovall, Incorporated, Dallas, Texas, bore the address underneath the endorsement on the back of the check of ~~3519 Fairmount~~, no city shown. It appeared this check was cashed on or before October 13, 1962.

On November 29, 1963, Mrs LENNIE CRAIG, Manager, Burdick's Apartments, at 3517 or 3519 Fairmount Avenue, Dallas, Texas, advised she has been manager here only since October 15, 1963. She advised she does not have records beyond this point. She stated RICHARD S. BURDICK, 3929 Normandy Street, Highland Park, Texas, would have these records. She further advised she has no recollection of LEE HARVEY OSWALD living there or has heard no rumors to that effect.

On November 29, 1963, Mr PAUL W. LAWYER, Apartment 10, Burdick Apartments, 3519 Fairmount Avenue, advised he is a long time resident of these apartments and does not remember anyone fitting the description of LEE HARVEY OSWALD living there. He stated the names HIDEELL, LEE or OSWALD do not sound familiar to him. Upon observation of pictures of LEE HARVEY OSWALD and JACK RUBY, LAWYER stated he has never seen either before.

On November 29, 1963, Mrs. JIM CROSS, Apartment 16, Burdick Apartments, 3519 Fairmount Avenue, advised she has lived here for eight months, during which time she has heard

~~rumors from other tenants that OSWALD lived in one of their apartments for a short time approximately one year ago.~~ She stated that all tenants except PAUL LAWYER have moved into the apartments since October of 1962. She advised she does not recognize the pictures of LEE HARVEY OSWALD and JACK RUBY that were displayed to her.

On November 29, 1963, E. Y. ASHCROFT, Manager, Fairmount Apartments, Dallas, Texas, advised he knows most of the tenants in the Burdick Apartments. He stated that the residents of the Fairmount Apartments are mostly aged and senile people. He further advised that none of these residents have made any reference as to knowing LEE HARVEY OSWALD. He stated that Mrs. JIM CROSS is well known for her ability to fabricate rumors of an exciting nature. He further advised he did not know OSWALD or RUBY.

On November 29, 1963, Mrs. ELIZABETH RANDALL, 3211 Beverly Drive, Highland Park, Texas, advised she was formerly manager of the Burdick Apartments for 8½ years. She stated she had a good memory of names and faces and does not recall LEE OSWALD as being one of the tenants. She advised also the names LEE and HIDEELL are not familiar to her. Upon being displayed photographs of OSWALD and RUBY, she advised they were not familiar to her.

On November 29, 1963, Mrs. RICHARD S. BURDICK, 3929 Normandy Street, Highland Park, Texas, made available her book and ledgers reflecting rental payments by tenants during pertinent periods. She stated her books reflect no rent paid by OSWALD or known aliases.

It is noted on the map of the city and surrounding areas that there is a Fairmont or Fairmount Street located in Irving, Texas and Duncanville, Texas, which are suburbs of Dallas.
