Dear Mr. Howard:

I understand that in a conversation you recently had with Mrs. Sylvia Meagher you told her that you had never heard of The Minority of One until one day someone showed you a copy that included a reprint of an article of yours. I also understand that you expressed indignation at that allegedly unauthorized and nor remunerated use of your writing. I was further told that you registered no objection to Mrs. Meagher's telling me of that conversation with you.

In this connection may I remind you, Sir, that in the course of our telephone conversation on July 3, 1967, you seemed to be easily aware of The Minority of One and that the copy containing your article is likely to have been one of the three copies we sent you--as we customarily do with all our contributors? May I further remind you that a specific authorization of our use of that article had been obtained^{ed} from you in the above telephone conversation, in which you were gracious enough to let yourself be persuaded to join the ranks of our many contributors who, when appearing in our pages, do so without honoraria. Just in case your memory continues to fail you, I am enclosing here a photostatic copy of your letter to me of July 5, 1967, confirming the here referred-to authorization and transmitting the actual article.

I trust that you will wish to withdraw your injurious allegations and inform also Mrs. Meagher to this effect.
