

Dear  Mrs. Meagher:

The Committee to Investigate Assassinations, in conjunction with Georgetown University, is going to hold a two-day Seminar/Conference on November 23rd and 24th ... marking the 10th Anniversary of President Kennedy's death. The general theme will be: Should the investigations of the assassinations be re-opened?

Although the format is incomplete, the Conference will not be limited to JFK's assassination but will also include the assassinations of Senator Robert Kennedy, Dr. Martin Luther King and the attempt on Governor Wallace. We shall have sessions on various aspects of political assassinations, such as physical evidence, medical evidence, legal problems, conspiracy theories in general, etc. Persons of varying "persuasions" will be invited in an effort to have balanced points of view.

We are extremely anxious to schedule you as a speaker and/or panelist. We know that your participation will add much to the success of the Conference.

Hopefully, we will have 800 participants, filling Georgetown's largest lecture hall. Again, hopefully, we expect to attract a sizeable number of staff members from "the Hill" and a large number of media people.

As matters now stand, we cannot offer to pay your travel expenses. If we get additional financing, we will pay travel expenses to the limit of our poor ability.
