- APRIL 23-29 ACCORDING TO HUIE (WM. HUIE, AUTHOR-LOOK MAGAZINE, ARTICLES AUTHORIZED BY RAY): ESCAPED ACROSS THE COUNTRYSIDE FOLLOWING BANKS OF MISS. RIVER TOWARD KANSAS. SIXTH DAY TOOK TRAIN TO EAST ST. LOUIS, PHONED A "FRIEND" WHO DROVE HIM TO EDWARDSVILLE, ILL. WHERE HE CAUGHT BUS TO CHICAGO. (EDWARDSVILLE IS NEAR ALTON WHERE HE HAD COMMITTED TWO ROBBERIES AND WHERE HIS FATHER HAD REMARRIED.)
