

CONTENTS OF MY "544 CAMP STREET - QUIGLEY PAMPHLET" FILE

This file concerns my lengthy but ultimately successful attempt to get a certain item from the Justice Department files using the Freedom of Information Act. The pamphlet in question proves that before the assassination of President Kennedy, the FBI had information connecting Lee Harvey Oswald to 544 Camp Street in New Orleans. This lead is not followed up in any of the pre-assassination reports; the pamphlet and its significance were apparently kept from the Warren Commission.

I would characterize the Justice Department's replies to me as evasive, delayed, imprecise, and often inaccurate - but all that may not have been deliberate. I described some but not all of my objections to their letters in my replies; I have not provided a detailed analysis. Also, except in my last letter, I have not said much about the significance of 544 Camp Street, which figured prominently in the early stages of the Garrison investigation. The importance of a link between Oswald and other persons associated with that address is well established, in part by Warren Commission documents.
