## QUESTIONS:

MR. SHANEYFELT TESTIFIED THAT EXHIBIT \& 85 WAS AN ALBUM OF BLACK \& WHITE PHOTOGRAPHS THAT HE HAD PREPARED FROM ZAPRUDER FRAMES /TI THROUGH 334.

WHY, THEN, DID MR. SHANEYFELT, AFTER TESTIFYING THAT THE WILLIS SLIDE 5 WAS SNAPPED AT FRAME 210 + THAT FRAME 210 WAS THE TIME WHEN THE PRESIDENT WAS FIRST SHOT, DID HE THEN REMOVE FRAMES 208, 209, 210, 211 AND THE TOP HALF OF FRAME RIA FROM THE RECORD? FRAME 212 HAS OBVIOUSLY BEEN TORN IN HALF--LOOKATTHETREE.

ALSO, IN EXHIBIT\& 893 WHICH PURPORTS TO DE A RE-ENACTMENT PHOTO OF FRAME 210 BUT WHICH IS, IN ACTUALITY, A PE-ENACTMENT PHOTO OF FRAME 208 - (NOTE THE CHANGE ON PRECEDING TABULATION CHARTS) - WHY DID MR. SHANEYFELT TRIM OFF WHAT WAS PHOTOGRAPHED BETWEEN THE SPROCKET HOLES?

COULD IT BE THAT THE MISSING FRAMES WOULD SHOW MR. WILLIS NOT SNAPPING HIS PICTURE AT FRAME 210?

THE PICTURES AND CHARTS WHICH FOLLOW WILL PROVE CONCLUSIVELY THAT THE WILLIS SLIDE \#ل WAS SNAPPED AT FRAME 202, IMMEDIATELY FOLLOWING THE FIRST SHOT, AND NOT AT FRAME 210 AS MR. SHANEYFELT HAS TESTIFIED.

NOTE WELL THAT THE OCCUPANTS OF THE CAR WERE HIDDEN FROM THE SIXTH FLOOR WINDOW BY THE FOLIAGE OF THE TREES IN FRAME 202 AND DID NOT EMERGE TO BE VIEWED FROM TWAT WINDOW UNTIL FRAME 210 .
