On December 19, 1963, Mr. NORMAN E. WARNER, First Secretary of Embassy, American Embassy, Port-au-Prince, Haiti, re-interviewed Mr. and Mrs. GEORGE DE MOHRENSCHILDT. The following is a quoted report of this interview:

> Information Concerning OSWALD Case Supplied to Norman E. Warner, First Secretary of Embassy, by Mr. and Mrs. George DEMOHRENSCHILDT on December 19,1963

1. Dates of Stay in Haiti

Mr. DeMchrenschildt stated that he had been in Haiti a couple of years ago (1961) but that his present stay began in March 1963. He was in Port-au-Prince for signature of a contract on March 13, having arrived a few days earlier and returning to the U.S. a few days later. He had spent approximately one weak in Haiti at this time. He returned to Dallas then where Mrs. DeMchrenschildt had remained. He and she left Dallas on April 19, driving to New York and Philadelphia (Mr. DeM. was involved in a law suit in the latter city). They drove back to Dallas at the end of May for "two days" to pack their things and make final arrangements for coming to Haiti. They exhibited an airline ticket date-stamped May 29, 1963 by the Dallas office of Pan American Airlines. They drove from Dallas to Miami at the end of May and shipped their car to Haiti from that point. They did not use their U. S. passport on these 1963 trips to Haiti, but state they entered with a tourist card. They showed Mr. Warner their joint U. S. passport which carries

no stamps dated later than 1961. They exhibited a Haitian residence permit showing their date of entry into Haiti as June 2, 1963. They state they have not returned to the United States since that date.

The DeMohrenschildts state that they did not see the Oswalds on their end of May visit to Dallas.

2. Oswald's Resume

Mr. DeMohranschildt states he returned the resume to Oswald. He "glanced through it, not very carefully, and gave it back to him." He does not remember precisely how long he kept the resume but thinks it was a matter of days. In any case, he states that he returned it to Oswald the next time he saw him.

3. Cawaid's Address When Gun Seen

Mrs. DeMohrenschildt's memory was not entirely clear on this point. At first she thought the Oswalds were living on Elsbath Street in Oakleaf (a suburb of Dallas) when she saw the gun. Mr. DeMohrenschildt was not positive that it was at this locative. Mrs. DeMohrenschildt thinks the time may have been early winter, or possibly late fall. After further reflection, Mr. and Mrs. DeMohrenschildt agreed that the occasion must have been around Easter in April 1963. They stated that by this time the Oswalds were living "around the corner" from the Elsbeth Street, about a block away. This new apartment was one flight up in an

old, or old-fashioned house situated "in front of a modernistic apartment house." (Mrs. DeMohrenschildt later consulted her personal telephone list which gave the address as 214 Neeley. The telephone number was Riverside 1-5501 but she explained that this was the number where Oswald worked.) They recalled that this apartment had a little terrace where the baby could play and also that there was a rose "tree" coming up the side of the house. They stated that they had taken a large Easter bunny to Mrs. Oswald for her baby. "This could have been the time I saw the gun," states Mrs. DeMohrenschildt. She recalls that Mrs. Oswald had opened a closet door, disclosing a gun standing inside. Mrs. Oswald remarked, "Look how crazy he is," referring to her husband's having the gun.

4. Comment to Gawald on Walker Incident

Mr. DeMchrenschildt states that he did not see the gun but having heard the women mention it, he asked Oswald in a joking menner whether he had taken a shot at Walker. Oswald kept a "poker face," he recalls, and "sort of waved it away" without saying anything. Mr. DeMohrenschildt explained to Mr. Warner that he has the "habit of kidding." He added that "it sounds serious now but we all believed the Walker incident was a publicity stunt." He said "everybody in Dallas" thought Walker had staged this himself for publicity.

5. Dental Treatment of Mrs. Oswald

Mrs. DeMohrenschildt confirms that she did take Mrs. Oswald in her car from Fort Worth to the dental clinic at Baylor University. This was "about a week, or maybe two" after the DeMohrenschildts met Mrs. Oswald. Later Mrs. DeMohrenschildt took Mrs. Oswald to a baby clinic.

6. Other Information and Other Persons Who Night Be Able to Supply Information

Mr. DeMohrenschildt explained that he and his wife are very active in helping needy people around Dallas and have been involved in many charitable works. He commented that "all the people in Dallas who knew the Oswalds knew them purely from the point of view of helping them;" there was sympathy for Mrs. Oswald in particular because she was Russian and in a strange land and could not speak English.

Other Sources: Samuel Ballen, an investment banker in Dallas. Oswald went to him for a job but was turned down because he had no specialty. Ballen has investment interests in many enterprises all over the country employing thousands of people.

Theo MELLER and his wife (who is "Russian"). Mrs. Meller is an engineering draughtsman. He works in Sangers Department Store in Dallas "as head of stock or something like that." They have no children. They took care of Marina Oswald and her baby for a while when Mrs. Oswald first was separated from her husband. (The DeMohrenschildts Thad moved Mrs. Oswald on that occasion, from the Elsbeth Street address to the Mellers.)
