

Charles Kramer, attorney, on Ed Harvey Show, WCAU Radio, Philadelphia,
November 19, 1965

Information received by telephone on 31 May 1966 on the front-page story by Robert J. Donovan in the LOS ANGELES TIMES of 30 May 1966

The story states that an FBI spokesman said on Sunday (29 May 1966) that the FBI report was in error...Epstein was challenged by the FBI on Sunday...the FBI was mistaken, they were not doctors, they were merely quoting doctors... the ultimate truth is in the autopsy report.

Epstein does not prove his case. No new evidence has come to light. There appear to be errors in the early FBI reports. If they are not errors, they could unhinge the conclusions in the Warren Report.

Inquest is but the first of many books to be issued on the same theme.

Fox...why do they not release those pictures, and why is Commander Humes under orders today not to talk to you about this testimony?

Kramer Well, not only Commander Humes; in fairness, every witness that has testified has been instructed not to discuss it with the public.

Fox Why?

Kramer At least every governmental...Well, I think it's fair, because all the confusion that occurred in the first few days was the result of the fact that the Dallas police were discussing it with the press, with the public on radio...

Fox...and why don't you now tell the story about your call to Commander Humes?

Kramer Well...it's a good point but I think you make more out of it than actually it justifies.
