"I have son years bese a stuont of hyprotism. From my study and knowledge of the efreets or hypnote frduction and the subsequent hypnotio states. I do not beileve it would be possfble to induce a post-hypnotio suggestion. orginarily, which would last long enough without a serios of repeated suggestions, to enable an individse? to sommet a crime especially one involving a series of disoretfonary judgenents.

"I realfze that in the city of New orleans my name has been associated with that of HE H HAPVEX OSNATD by certain persons. Honever, to the best of my recojuection and belief I have never known ISE HARVEY OSMAID or JACK RUBY.
