Dr. Nicholas Chetta, coroner, did autopsy on Ferrie  
Melvin Coffey, friend who accompanied Ferrie to Texas 11/23/63  
Thomas Compton, friend of Ferrie, Hammond, La., researcher on narcotics addiction  
Al Crouch, interviewed Russo for Baton Rouge TV  
Raymon Cummings, Dallas ex-cab driver, alleges took Oswald and Ferrie to Ruby club early 1963  
J.B. Dauenhauer, subpoenaed by Garrison for questioning 3/7/67, ex-bookkeeper Trade Mart  
Don DeLone, Port official, said Shaw in San Francisco 11/22/63  
Shirley Dial, motel clerk, Galveston, re Ferrie on 11/23/63  
Donald Doodie, knew Clay Shaw, questioned by grand jury 3/24/67  
Mary Doveri, motel clerk Galveston re Ferrie presence 11/23/63  
Irving Dymond, attorney for Clay Shaw  
Dr. Esmond A. Fatter, hypnotized Russo for Garrison  
Lee Fletcher, porter Alamotel, Houston re Ferrie presence 11/23/63  
Anthony Gerrets, Secret Service agent who interviewed Jack Martin  
G. Wray Gill, attorney for Carlos Marcello, employed Ferrie 11/22/63  
Pascual Enrique Ruedolo Gongora, alleged by Stanley Ross of El Tiempo to be member of one of four assassination teams sent by Castro, see CE 1444  
Manuel Garcia Gonzales, may be unidentified man in Pizzo photo (Oswald handing out leaflets New Orleans street 8/16/63); wanted on narcotics charge  
William Gurvich, a chief investigator for Garrison  
Sheriff Louis Heyd, responsible for security, Clay Shaw hearing  
Louis Ivon, chief investigator for Garrison  
Rosemary James, reporter, States-Item; interviewed Ferrie 2/21/67  
Herman S. Kahlman, assistant district attorney New Orleans  
Frank Klein, former District Attorney, involved in arrest of Ferrie 11/25/63  
Al Landry, friend of Ferrie who had to be extricated by Russo  
George Lardner, reporter, last person to see Ferrie alive  
James Lewallen, subpoenaed by Garrison, friend of Ferrie, works at Michoud (see Alba testimony)

David Lewis, baggage handler and "private detective," knew Ferrie  
Clyde Limbaugh, singer, claims he saw Oswald and Tippit with Ruby before 11/22/63  
James R. Liscombe, ex-convict, created disturbance outside courthouse at Shaw hearing  
Layton Maartens, friend of Ferrie, indicted for perjury by grand jury 4/6/67  
Betty McManes, subject of a warrant issued by Garrison, denies she was at Ferrie party  
Dante Marachini, mentioned in connection with "Castro teams of assassins"  
Carlos Marcello, Mafia figure, Ferrie worked for his lawyer Gill  
Jack Martin, said Ferrie and Oswald were linked, then admitted his story was false  
Sandra Moffett, allegedly present at Ferrie's party, per Russo  
Gordon Novel, ex-owner New Orleans bar; ordered arrested by Garrison; looks like Oswald  
Malcolm V. O'Hara, judge at Shaw hearing, said to be hostile toward Garrison  
Al Oser, assistant District Attorney New Orleans  
Salvatore Panzeca, attorney for Shaw  
Lefty Peterson, alleged by Russo to have been a guest at Ferrie's party  
George Piazza, attorney for James Lewallen  
Joseph M. Rault, Jr., financial backer of Garrison (Truth and Consequences)  
John W. Rice, Secret Service agent, interviewed Jack Martin  
Willard E. Robertson, financial backer of Garrison  
Perry Raymond Russo, witness vs Clay Shaw at hearing  
David Snyder, reporter, New Orleans States-Item, went to Ferrie's apt. 2/21/67  
Arthur Edward Strout, Boston dishwasher, claims photo of Oswald/Ruby/Russo at Carousel  
Miguel Torres, 26-year-old Cuban, alleged former neighbor of Oswald's, transferred from  
State Prison to Orleans Parish jail for questioning 1/30/67  
Edward Wegman, attorney for Clay Shaw  
Dr. Ronald A. Welsh, pathologist, studied Ferrie autopsy  
Sam "Monk" Zelden, attorney for Dean Adams Andrews, Jr.
