p. 21 KA heard in "next letter"  
from R. P. that 2 barium pentaborate  
at Tacoma (Harold A. Dahl =

Fred L. Crisman has seen many  
UFOs & had fragments from one.

p. 23 KA asked RP 200 to  
go Tacoma & investigate

p. 25 On 7/29/47 KA flew  
Boise to Tacoma p. 26 over  
Union, Oregon, sighted 25 cross-  
colored objects, coming → him  
head on & fast p. 27 at dusk  
arrived Tacoma, at Navy's  
airport p. 29 Collect H.A. Dahl,  
not aware see KA, said, go  
home forget hole thing. At end H.A.D.  
agreed see KA in 1/2 hr at hotel

P. 31 HAD finally, took KA  
that in am of 6/21/47 he patrolling  
East bay of Navy Island. 2 crewmen  
his 15-yr boy & dog aboard.  
About 2 pm saw 6 large do-not  
plyed UFOs about 2000 ft above  
water - 5 circling the 6<sup>th</sup>  
which seemed in trouble & lost  
altitude P. 32 it began spewing  
forth 1000's pieces "penetrator"  
(metal, white very light, then  
black or darker metal rained  
down - Ann's arm injured  
dog hit & killed P. 33 picked up  
metal pieces, very hot, also  
light "white" Returned Tacoma  
where boy treated at hosp. Had to  
explain to his superior, Fred L. Cusumano,  
why boat damaged, gave him  
camera (had taken 3-4 photos) &  
metal fragments. F.H.C. went to  
University beach, where HAD  
thought 20 tons fragments fallen

P.34. HAD said next man  
came to his house, second ordinary  
(about 40) P.35 Had breakfast  
then at small cafe Tacoma where  
man related in detail HAD's  
experience - said if Cone family,  
do not discuss, He did,

angry. In pm FLC returned  
from Murray Island, not make  
to pay P.36 KA did not

know what think of HAD's story  
HAD said, to Recy's house to

see metal. Went there P.37

40-yr woman, Recy, HAD

headed KA rock colony, say  
it was fragment for Murray Is.

P.38 next am HAD and FLC  
arrived 9.30 at KA hotel room.

FLC short, stocky, dark angular  
Cheerful = alert, eager tell his story,  
Had gone M Is, next am check on  
20 tons metal, had seen a donut WFO  
per HAD. FLC said, held commercial  
pilot's license; flew + 100 missions  
over Burma WWII.

KA felt FLC ~~wrote~~ dominate  
the conversation, HAD to quit.

KA found digging his pocket  
a full of ash or embers in  
Habs on 1/12/47, began Helenie  
FKC = HAD story, asked if they  
would he call Cpt J.E. Smith of  
WA P. 41 KA met Smith  
Seattle, flew him Tacoma,  
P. 42 arriving 3pm FLC  
waiting at Bang's airport, said  
would go for HAD, both in car  
at hotel. HAD & FLC around  
told story again P. 43 read  
X-exam but Smith case was  
break down their story P. 44  
that night KA - Smith uneasy  
had feeling dangerous got  
involved in HAD - FLC  
suspected hoax, also, USSR trick  
to get info out of them. P. 45 Phone  
call, was Ted Morillo of UPI  
paying Crookpot called him in  
verbatim of all said in

KA hotel room price arrived  
there. Suspected FLC or HAD  
leaking info. P46 next am  
KA & Smith woke up by HAD =  
FLC, bearing white metal  
pieces locked in room  
& went breakfast = FLC/HAD  
& Crew, KA took movies of  
Smith FLC & HAD & their cars  
outside after eating, then  
cell 4 returned from 502 Westling  
Hotel & inspected metals. P47  
noticed on one piece that 2 parts  
of it had been riveted (square long  
rivets) (unfamiliar). Did not  
let on suspected loss P48  
FLC when asked for photos said  
unable locate them in room, would  
bring in from. KA then suggested  
call Davidson & Brown of  
Military Intelligence. FLC very  
eager do it but HAD seemed  
fretted. Said if called  
D & B in would refuse talk
