I CAN FIND NO STATEMENT OR REPORT BY LUMPKIN.

In Curry's Testimony, Volume 4, p. 153:

Mr. Rankin. (asking about Oswald) Did you give any instructions about the security or how he should be protected during this time?

Mr. Curry. No; I personally didn't. Deputy Chief Lumpkin, who has charge of the service division which is the jail security, he told me that he had ordered two guards be placed on him right outside his cell and kept there 24 hours a day as long as we had him.

Mr. Rankin. Do you know what was done about that?

Mr. Curry. It was carried out. He told me that this was carried out.

George L. Lumpkin. He asked me at the Mr. Gurry. George Lumpkin. hospital if I didn't want him to go back to the Texas School Book Depository and assist in the search of the building and I told him yes, and he did go back, and took over on the search of the building then.
