- James A. Jackson's check stub. Was there any writing on the reverse side? Archives couldn't find it. LHO did not have it in August.
- CIA 1004-400 re "interview in Copenhagen." Defector? CIA Agent?
 ---- ? See Marina's statement to Katya Ford re LHO's being in Russia "with the Trade Fair" (CD 5, p. 259)
- Who is Harold Sherwin Gordon in the ONI file?
- There were two pairs of men's shoes in LHO's room at 1026 N. Beckley. Marina cannot identify one pair. (See Vol. 1, p. 121; Vol. 16, p. 514; shoes are pictured in Vol. 24, p. 350) One pair described as "John Hardy brand" in Vol. 20, p. 636. There were only two Hardy Shoe Stores in Dallas in 1963 one on Jefferson where Johnny Calvin Brewer worked (Vol. 24, p. 203), and one in South Oak Cliff Shopping Center.
