What degree of probability of a conspiracy? Accoustical evidence said beyond a reasonable doubt, 95% or better so I would say that is what we mean when we talk about probability. Q Madrid Paris Havana Mexico. Spent too much time away from scene of crime? Tried go where evidence led. Q No, tape is not really basis for conclusions. Tape was corroborative of other evidence already in record - Some 178 by WC testified that from JFK. No, not saying HCA would have found conspiracy without the tape, but if tape had not existed, HSCA would not have concluded LHO acted alone. Our report will reveal his association with many other ppl. Q Yes, we will establish LHO relationships in N. Orls. Q Any serious dissent? Not really, only place some reservation was on 1st finding, re 3 shots. One member wanted to wait 4 results ++ testing on firing time - FBI said 2.25 to 2.3 secs. Cornwell & Blakey, hit target 3x in 2 secs with same type rifle. The other member voted without any vocal reason for his vote. Q How anxious 4 each investing to be pursued? Brownson film is of real interest. Only turned over to us about 3 weeks ago. Panel found nothing but suggested further study. Also DT should look at the accoustical evidence, maybe do ++ study.

¶ We have come out with condemnations that vindicate what 80 to 90% American people suspected all along. ¶ How can public have any confidence that investigation by DT will get anywhere? Well, we just have to have faith ... misfiled (Byers) 1974 ... ¶ Any effort FBI CIA cover things up? Report tries to put it in perspective. Inadequate, negligent, abused rights. CIA did not tell WC re Castro plots, re Norzambo, did not tell WC all they knew, to that degree they did not perform their job properly. They admitted they had made some mistakes, these were things the FBI was ashamed of ¶ (re FBI Cointelpro moral respons 4 MLK assassination) (It was he in the report - that they were creating an atmosphere) ¶ In 24 hrs JET = FBI concluded Ray, acted alone, pressed fugitive case only, rather than conspiratorial aspect. Inadequate, negligent. ¶ In Sept. NAA, fragments did not match in weight. Are you doing anything to find the fragments that weren't there? No, not. ¶ Was JERay paid? HCA concluded he was not paid. ¶ Where is the conspiracy then? Kaufman & Sutherland St. Louis, Byers testimony offered \$50,000. HSCA has estab the communication of that offer to Ray, through circumstantial evidence of associations.

Q The report itself which will be 30-40 volumes
which has not yet been written covering JFK
& MLK assassinations anticipates 39-40 volumes

Q Left with loose ends and unanswered questions?
Should Congress do something more? We did
leave some loose ends but we did find
many things never revealed before. The King
assassination had never been investigated. The \$
was well spent. We fulfilled our mandate
from the Congress. Now, he will keep promise
not to seek reconstitution or further funding.
