2 cases before HCA - JFK & MLK. Will deal only w JFK.
First requirement of a theory is fit all the facts.
Great problem w JFK is get to have some facts →
justice theory → truth. What really happened
Dealey Plaza? Very troublesome question.

His problem was figure out what a Congress's Com could
add to a tragedy. Foot-finding 15 years after
difficult if not impossible. Witnesses' testimony
was no longer valid. Therefore bet on strategy of
looking to science & files, not people. Found
reason CIA classified info is 2 wide how little
they know. Solution of JFK case not in CIA files.
Had unprecedented access CIA files & ppl
Ditto FBI

Re science involved - 2 or 3 shots in 7.9 secs
by LHO. per official finding. No ev of a
conspiracy. No "credible" evidence. But
what did HCA find? 4 shots not 3

1 from TSBD missed, per 2 films, can see
Gov C turn, then turn very quickly again.

Gov C says, but by second shot, which HCA
accepts. Based on 2 films and on tape

7.9 secs from 1st to 4th shot

2nd shot per WC hit JFK & single missile
thru Gov C all rounds. Widely objected to
by critics but HCA estab single bullet
theory beyond all reasonable doubt. Based on
precise positions JFK's Gov C, precise location
of wounds. 14' to - to TSBD windows

Also CE 399 came from LHO rifle

NAA estab it hit Gov C wrist

3rd bullet & this is area of controversy, fired from
 GK, a surprising finding of HCA. Not true
 did it at last minute, was heard & accounted
 evidence period July - August.

Tape is central part of the analysis. DP McQuinn
 - microphone deliberately stuck - he on wrong
 channel, one not two, so he picks up
 sound of bullets being fired. Critics had long
 suggested DP implicated in assassination
 effort block use roads by keeping buttons open
 sent tape to Bolt & Co. & Berger, very sophisticated
 analysis, \$50,000 on filter analysis proved
 unnecessary. In test. Berger only willing
 offer 50/50 estimate. Followed by Weiss
 & Ashkenazy + work (explains techniques
 linking sound to microphone directly plus
 sound hitting all structures & bouncing back to
 microphone - sounds like bang bang bang bang bang)
 Actually involves a fingerprint unique to that
 urban environment. To a degree of
 certainty of 95% to plus. Is sound of
 Carion bell, not a D Pledge. But
 Ashkenazy said, only from place identical
 to D Pledge. In addition, there is an
 in-wave preceding the loud noise - an
 audible sonic boom. Whoever fired from GK fired
 a pipe-sonic weapon.

Once we learned could have been pistol
 not rifle unless if a DP officer could have
 fired a pistol, but found direction of
 fired at JFK limousine.

Ironically is a photo taken (by Mrs Newman) showing fence where second assassin had to be standing. Unfortunately was polaroid camera & has deteriorated to pt where enhancement is not profitable and was not done. But at spot where assassin had to be standing, there is an irregularity. HCA miss no evaluation but suggests that it is present & not absent.

Were 100s ppl in PPlace that day. What evidence beyond science for GK shot? 171 interviewed, heard 2 to 4 shots fired, 46 said for TSB 20 said GK remainder did not know, or fired from elsewhere. Among those who heard shots first shot is policeman riding to apt of Mrs JFK. Another was a SA agent. Zapruder also, Newman & family, between JFK & fence, hit the ground, knew he was in line of fire. Holland on overpass heard 4 shots, 2 from GK, saw puff of smoke.

Was accepted but find yes impl if not cleaned will produce smoke.

Bullet fired from GK did not hit JFK, the evidence is unambiguous. 4th shot fired from TSB but both JFK had eg HTO 3rd shot killed JFK
