TO PICK UP SOME CURTAIN RODS FOR HIS APARTMENT ON BECKLEY WHICH HE SAID WAS GOING TO OBTAIN FOR MRS. PAYNE. ON MORNING OF NOV. TWENTYTWO, LAST, OSWALD RODE TO WORK WITH FRAZIER. OSWALD HAD WITH HIM A PACKAGE IN LARGE DEPARTMENT STORE PAPER SACK WHICH HE PLACED ON BACK SEAT AND SAID WERE THE CURTAIN RODS. FRAZIER STATES THIS PACKAGE LARGE ENOUGH TO HAVE ACCOMODATED A "BROKEN DOWN" RIFLE. UPON ARRIVAL AT WORK OSWALD TOOK THIS PACKAGE FROM CAR AND WENT INTO PLACE OF EMPLOYMENT WHILE FRAZIER STAYED SHORT TIME IN CAR RUNNING MOTOR TO CHARGE BATTERY. FRAZIER DID NOT SUBSEQUENTLY SEE OSWALD.

LINNIE MAE RANDLE, TWO FOUR THREE NINE WEST FIFTH, IRVING, TEXAS, ADVISED SHE WAS THE SISTER OF BUELL WESLEY FRAZIER AND RESIDED WITH HIM AT SAID RESIDENCE. STATES HAS KNOWN SUBJECT AND WIFE ABOUT SIX WEEKS AND THAT SUBJECT USUALLY RIDES HOME FROM WORK WITH FRAZIER ON FRIDAY NIGHT AND STAYS WITH HIS WIFE MARINA OSWALD AT TWO FIVE ONE FIVE WEST FIFTH AND FRAZIER TAKES HIM BACK TO WORK ON MONDAY. STATED ABOUT SEVEN FIFTEEN PM ON NIGHT OF NOV. TWENTYONE, LAST, SHE OBSERVED FRAZIER BRINGING OSWALD TO TWO FIVE ONE FIVE WEST FIFTH. THEREAFTER INQUIRED OF

FRAZIER WHAT OSWALD WAS DOING COMING TO IRVING ON THURSDAY NIGHT AS HE USUALLY CAME ON FRIDAY NIGHT. FRAZIER TOLD HER THAT OSWALD STATED HIS REASON FOR COMING THURSDAY NIGHT WAS BECAUSE HE WAS FIXING UP HIS APARTMENT AND MRS. RUTH PAYNE, TWO FIVE ONE FIVE WEST FIFTH, WAS GOING TO GIVE HIM SOME CURTAIN RODS. RANDLE STATED ABOUT SEVEN FIFTEEN AM, NOV. TWENTYTWO, LAST, SHE OBSERVED OSWALD WALKING UP DRIVEWAY AT HER RESIDENCE AND SAW HIM PUT A LONG BROWN PACKAGE ABOUT THREE FEET BY SIX INCHES INTO THE BACK SEAT AREA OF FRAZIER/S FIFTYFOUR BLACK FOUR DOOR CHEVROLET. THEREAFTER OSWALD WALKED BACK TO ENTRANCE AREA OF RESIDENCE AND WAITED FOR FRAZIER TO COME OUT. STATES OSWALD WEARING TAN OR LIGHT BROWN SHIRT, BAREHEADED, DOES NOT RECALL COLOR OF TROUSERS.

JACK EDWIN DOUGHERTY, ONE EIGHT TWO SEVEN SOUTH MARSALIS, DALLAS, EMPLOYED AS AN "ORDER FILLER" BY TSBD, ADVISED HE WAS FIRST EMPLOYEE OF THIS FIRM TO REPORT FOR WORK ON NOV. TWENTYTWO, LAST. RECALLS ONLY VAGUELY SEEING OSWALD, FELLOW EMPLOYEE, AT WORK AT APPROXIMATELY EIGHT AM, BUT RECALLS DEFINITELY HAVING SEEN OSWALD AT ABOUT ELEVEN AM. DOES NOT RECALL HAVING SEEN OSWALD AT WORK SUBSEQUENT TO APPROXIMATELY

ELEVEN AM. DID NOT SEE OSWALD ENTER BUILDING.

DANNY GARCIA ARCE, EMPLOYEE, TSBD, ADVISED HE SAW OSWALD AT TSBD AT APPROXIMATELY ELEVEN FIFTY AM, NOV. TWENTYTWO, LAST, ON FIFTH FLOOR OF BUILDING, NEAR ELEVATORS. THIS WAS THE LATEST TIME ARCE OBSERVED OSWALD IN BUILDING AS ARCE LEFT FOR LUNCH AT ELEVEN FIFTY AM.

MR. ROY S. TRULY, WAREHOUSE SUPERINTENDENT, OBSERVED OSWALD AT WORK ON MORNING OF NOVEMBER TWENTYTWO. OSWALD HAD ACCESS TO ALL FLOORS OF BUILDING IN HIS REGULAR OCCUPATION OF FILLING ORDERS FOR SCHOOL BOOKS. TRULY WAS ON SIDEWALK IN FRONT OF HIS PLACE OF EMPLOYMENT WITH PRACTICALLY ALL OTHER EMPLOYEES FROM BUILDING WHEN KENNEDY WAS SHOT. HE IMMEDIATELY ACCOMPANIED A POLICE OFFICER INTO THE BUILDING AND UP THE STAIRS TO THE SECOND FLOOR, WHERE THEY OBSERVED OSWALD ALONE IN THE COMPANY SNACK BAR. SNACK BAR IN CENTER OF BUILDING, HAS NO WINDOWS AND WAS UNUSUAL PLACE FOR ANYONE TO BE AT THAT TIME. AFTER SEARCH OF BUILDING COMPLETED, OSWALD COULD NOT BE LOCATED.

WITNESS BILLY NOLAN LOVELADY, COWORKER OF SUSPECT LEE HARVEY OSWALD, OBSERVED OSWALD ON FIFTH FLOOR, TSBD BUILDING ABOUT ELEVEN FIFTY AM. FOLLOWING THE SHOOTING, OSWALD NOT OBSERVED AGAIN BY LOVELADY.

MR. WILLIAM H. SHELLEY, DEPARTMENT MANAGER, TSBD, OBSERVED OSWALD AT WORK ON THE FIRST FLOOR OF THAT BUILDING SOMETIME

BETWEEN ELEVEN FORTYFIVE AM AND NOON ON NOVEMBER TWENTYTWO LAST. OSWALD WORKS UNDER SHELLEY, BUT OSWALD DID NOT REQUEST AND SHELLEY DID NOT GIVE PERMISSION FOR OSWALD TO LEAVE WORK EARLY ON NOV. TWENTYTWO LAST.

CHARLES DOUGLAS GIVENS, EMPLOYEE, TSBD, WORKED ON SIXTH FLOOR UNTIL ABOUT ELEVEN THIRTY AM. LEFT AT THIS TIME GOING DOWN ON ELEVATOR. SAW OSWALD ON FIFTH FLOOR AS LEFT GOING DOWN. OSWALD TOLD HIM TO CLOSE THE GATES ON THE ELEVATOR WHEN HE GOT TO FIRST FLOOR /SO OSWALD COULD SIGNAL FOR ELEVATOR LATER/. GIVENS STAYED ON FIRST FLOOR UNTIL TWELVE O-CLOCK AND THEN WALKED OUT OF THE BUILDING TO WATCH THE PARADE PASS. OSWALD WAS READING PAPER IN THE FIRST FLOOR DOMINO ROOM SEVEN FIFTY AM NOV. TWENTYTWO LAST WHEN GIVENS CAME TO WORK.

BONNIE RAY WILLIAMS, EMPLOYEE OF TSBD, KNEW OSWALD AS LEE. SAW HIM AT ABOUT ELEVEN THIRTY AM NOV. TWENTYTWO LAST ON FIFTH FLOOR. AT TWELVE NOON WILLIAMS RODE UP ON ELEVATOR FROM FIRST FLOOR TO SIXTH FLOOR WHERE HE HAD BEEN WORKING ALL MORNING. SPENT ABOUT THREE MINUTES THERE, WALKED DOWN TO

FIFTH FLOOR AFTER SEEING NO ONE ON SIXTH FLOOR. WAS EATING AND LOOKING OUT WINDOW. SAW PRESIDENT/S CAR TURN WEST ON ELM FROM HOUSTON STREET AND THEN HEARD AT LEAST TWO SHOTS WHICH SOUNDED LIKE THEY WERE FIRED RIGHT OVER HIS HEAD. THEN RAN DOWN TO WEST END OF SAME FLOOR. HE DID NOT SEE OSWALD AT THIS TIME OR LATER.

HOWARD LESLIE BRENNAN WAS SEATED ACROSS STREET FROM TSBD BUILDING ABOUT TWELVE THIRTY PM WHEN HEARD TWO OR THREE SHOTS. PRESIDENTIAL CAR HAD JUST TURNED LEFT OFF HOUSTON ST. WHEN SHOOTING OCCURRED. BRENNAN LOOKED UP IN TIME TO SEE PERSON AT WINDOW ON SIXTH FLOOR OF TSBD BUILDING TAKE "DEAD AIM" AND FIRE LAST SHOT WITH WEAPON POINTED TOWARD PRESIDENTIAL CAR. DESCRIBED RIFLEMAN AS WHITE MALE, EARLY THIRTIES, WEARING LIGHT COLORED CLOTHES. BRENNAN SAID HE LATER PICKED OSWALD OUT OF POLICE LINEUP AS PERSON WHO RESEMBLED INDIVIDUAL HE OBSERVED IN WINDOW SHOOTING RIFLE, BUT UNABLE TO MAKE POSITIVE IDENTIFICATION.

CECIL J. MC WATTERS, BUS DRIVER WHO WAS IN VICINITY OF ASSASSINATION ABOUT TWELVE FORTYFIVE PM PICKED UP A MAN IN

THIS VICINITY WHO SAID THE PRESIDENT HAD BEEN SHOT IN THE TEMPLE. . STATES HE IDENTIFIED A TRANSFER SHOWN TO HIM AT THE DALLAS PD AS ONE ISSUED BY HIM ON THIS PARTICULAR RUN AND WHICH HE UNDERSTOOD HAD BEEN FOUND ON OSWALD. MC WATTERS SAID HE PICKED OSWALD OUT OF LINEUP AT PD AS BEING THE ONLY ONE IN THE LINEUP WHO RESEMBLED THE MAN ON HIS BUS BUT CANNOT POSITIVELY IDENTIFY OSWALD AS THIS MAN. MC WATTERS BUS RUN GOES TO AREA NEAR WHERE OSWALD LIVES ON BECKLEY.

MRS. EARLENE ROBERTS, ONE ZERO TWO SIX N. BECKLEY, SAID OSWALD AS O. H. LEE HAS LIVED THERE SINCE OCT. FOURTEEN LAST. HE CAME IN ABOUT ONE PM, GOT A JACKET, AND LEFT IMMEDIATELY. SHE COMMENTED HE WAS IN A HURRY.

AT APPROXIMATELY ONE THIRTEEN, PM, DALLAS PATROLMAN TIPPITT WAS SHOT AND KILLED IN FOUR HUNDRED BLOCK EAST TENTH STREET. DISTANCE FROM OSWALD-S RESIDENCE TO FOUR HUNDRED BLOCK EAST TENTH IS POINT EIGHT MILE AND TAKES APPROXIMATELY TEN TO FIFTEEN MINUTES TO WALK.

SHOOTING OF OFFICER OBSERVED BY WITNESS, WHO STATED KILLER FLED SCENE IN WESTERLY DIRECTION. AT ABOUT TWO PM POLICE RECEIVED INFO THAT SUSPICIOUS PERSON WAS AT TEXAS THEATER, POINT SIX OF A MILE FROM FOUR HUNDRED BLOCK EAST TENTH STREET. POLICE OFFICERS AND BUREAU AGENTS CONVERGED ON THEATER WHERE OSWALD TAKEN INTO CUSTODY AFTER ATTEMPTING TO RESIST OFFICERS AND TO FIRE HIS REVOLVER AT THEM. REVOLVER IN POSSESSION WAS POINT THIRTYEIGHT SUBNOSE S AND W, SN FIVE ONE ZERO TWO ONE ZERO, WITH NUMBER ON CHAMBER HINGE - SIX FIVE TWO FOUR EIGHT, ORIGIN AS YET UNDETERMINED. OSWALD IDENTIFIED BY WITNESS TO SHOOTING.

DALLAS PD, CRIME LAB ON NOVEMBER TWENTYTWO, LAST, PROCESSED RIFLE RECOVERED ON SIXTH FLOOR OF TEXAS SCHOOL BOOK DEPOSITORY AND WERE SUCCESSFUL IN RAISING PARTIAL LATENT PRINT. NO IDENTIFICATION OF PARTIAL LATENT MADE BY DALLAS PD.

DALLAS PD LABORATORY HAS TAKEN DETAILED PHOTOGRAPHS OF SIXTH FLOOR, MADE AN EXACT DRAWING OF SAME, CONDUCTED COMPLETE CRIME SCENE SEARCH. PD LAB LOCATED LATENT PRINT ON WRAPPING PAPER FOUND ON A BUNDLE OF BOOKS OR SCHOOL SUPPLIES ON WHICH ASSASSIN HAD APPARENTLY SAT WHILE WAITING FOR PRESIDENT-S ARRIVAL. THIS POSITIVELY IDENTIFIED BY DALLAS PD CRIME LAB AS PALM PRINT OF OSWALD. PD LAB ALSO FOUND WHAT APPEARED TO BE BROWN PAPER AND TAPE IN WHICH RIFLE HAD BEEN WRAPPED FOR CONCEALMENT. RIFLE WAS RECOVERED ON SIXTH FLOOR OF BUILDING. PHOTOGRAPHS AND DRAWINGS BY PD WILL BE AVAILABLE TO FBI.

PHOTOS OF RIFLE WHICH SHOT PRESIDENT AND GOVERNOR AS WELL AS BULLET HULLS BEING BROUGHT TO LABORATORY WITH RIFLE, BULLET HULLS AND OTHER EVIDENCE.

FOLLOWING INTERVIEWS CONDUCTED JOINTLY BY FBI AND DALLAS PD SUBJECT LEE HARVEY OSWALD, AKA. ALEX JAMES HIDELL, ONE ZERO TWO SIX ⁿX. BECKLEY, WM, BORN OCT. EIGHTEEN, THIRTYNINE, NEW ORLEANS, LAS., FIVE FEET NINE INCHES, ONE FORTY LBS., MEDIUM BROWN HAIR, MEDIUM LENGTH, BLUE GRAY EYES, NO TATTOOS OR MARKS, FORMER USMC ONE SIX FIVE THREE TWO THREE ZERO, DENIES KNOWLEDGE OR PARTICIPATION IN KILLING OF PRES. JOHN F. KENNEDY OR DALLAS

POLICE OFFICER J. D. TIPPETT, NOV. TWENTYTWO, LAST. STATES DOES NOT OWN RIFLE. SAW RIFLE DAY BEFORE YESTERDAY IN TEXAS SCHOOL BOOK DEPOSITORY AND MR. TRULEY /MANAGER/ AND TWO GENTLEMEN WERE LOOKING AT IT. STATES WAS ON SECOND FLOOR OF SAME BUILDING, NOV. TWENTYTWO, LAST, HAVING JUST PURCHASED COKE, WHEN DALLAS PD OFFICER CAME IN WITH PISTOL AND ASKED IF HE WORKED THERE. TOOK COKE DOWN TO FIRST FLOOR AND ATE LUNCH IN EMPLOYEE LUNCH ROOM. THEN WENT OUTDOORS FOR FIVE TO TEN MINUTES WITH BILL SHELLY, FOREMAN. OSWALD STATES LEFT WORK BECAUSE OF OPINION BASED ON REMARKS OF BILL SHELLY THAT BECAUSE OF THE CONFUSION IN THE BUILDING RESULTING FROM SEARCH BY DALLAS PD THAT THERE WAS NOT GOING TO BE ANY WORK THE REST OF THE DAY. STATED THAT HIS REGULAR WORK HOURS ARE FROM EIGHT AM TO FOUR PM, HOWEVER, BUSINESS DOES NOT HAVE A TIME CLOCK. HIS USUAL PLACE OF EMPLOYMENT IS ON FIRST FLOOR BUT HE FREQUENTLY GOES TO FOURTH, FIFTH, SIXTH AND SEVENTH FLOORS TO GET BOOKS, WHICH WAS OCCASION ON NOVEMBER TWENTYTWO, LAST. AFTER LEAVING BUILDING, HE WENT TO RESIDENCE AT ONE ZERO TWO SIX NORTH BECKLEY BY BUS AND CHANGED HIS TROUSERS AND PICKED UP HIS PISTOL AND PROCEEDED TO TEXAS THEATER WHERE HE WAS

ARRESTED BY DALLAS POLICE OFFICERS. CLAIMS NO POLITICAL BELIEFS BUT STATES BELONGS TO "FAIR PLAY FOR CUBA COMMITTEE", NEW ORLEANS BRANCH. STATES THIS COMMITTEE SUPPORTS THE CASTRO REVOLUTION AND HAS HEAD-QUARTERS IN NEW YORK CITY. DECLINED TO FURNISH OFFICERS. CLAIMS LIVED IN USSR FOR THREE YEARS AND WRITES TO WIFE-S RELATIVES IN USSR.

ADMITS WRITING TO SOVIET EMBASSY IN WASHINGTON, D. C. COMPLAINING ABOUT FBI ACCOSTING WIFE.

MARINA OSWALD, TWO FIVE ONE FIVE WEST FIFTH, IRVING, TEXAS, WF, AGE TWENTYTWO BORN USSR, WIFE OF LEE HARVEY OSWALD, ENTERED US VIEW NEW YORK CITY WITH HIM JUNE THIRTEEN, SIXTYTWO. STATES OSWALD SPENT NIGHT OF NOV. TWENTYONE, LAST WITH HER AT RESIDENCE OF RUTH PAYNE, TWO FIVE ONE FIVE WEST FIFTH, IRVING, TEXAS, LEFT RESIDENCE MORNING OF NOV. TWENTYTWO, LAST BEFORE SHE OR PAYNE AWAKENED. KNOWS HE OWNED RIFLE WITH WHICH HUNTED IN RUSSIA.

TWO WEEKS AGO SHE OBSERVED A RIFLE WRAPPED IN BLANKET IN GARAGE AT TWO FIVE ONE FIVE WEST FIFTH, BUT DOESN-T KNOW IF THIS SAME GUN. ON NOVEMBER TWENTYTWO, LAST, OBSERVED SAME BLANKET IN GARAGE BUT RIFLE WAS MISSING. STATES WOULD NOT BE ABLE TO IDENTIFY RIFLE AS ALL GUNS LOOKED ALIKE TO HER. WAS SHOWN RIFLE FOUND AT TEXAS

SCHOOL BOOK DEPOSITORY, FOUR ONE ONE ELM, NOVEMBER TWENTYTWO, LAST, AND STATED UNABLE TO IDENTIFY.

MRS. RUTH PAYNE, TWO FIVE ONE FIVE W. FIFTH, IRVING, TEXAS, STATES MET OSWALD AND WIFE EARLY PART OF SIXTYTHREE AT PARTY. BROUGHT MARINA OSWALD TO DALLAS FROM NEW ORLEANS ABOUT SEPTEMBER TWENTYFOUR, LAST, TO LIVE WITH HER DURING BIRTH OF BABY. CONFIRMED OSWALD SPENT NIGHT OF NOVEMBER TWENTYONE, LAST AT HER RESIDENCE AND LEFT BEFORE SHE AWAKENED. HAS NEVER SEEN HIM WITH RIFLE AND DID NOT KNOW HE HAD ONE IN HER GARAGE. STATES ON NIGHT OF NOVEMBER TWENTYONE, LAST, HE MADE NO MENTION OF CURTAIN RODS AND SHE HAD NO PLANS TO GIVE HIM ANY.

MICHAEL PAYNE, TWO THREE SEVEN SEVEN DALWORTH, GRAND PRAIRIE, TEXAS, PRESENTLY SEPARATED FROM WIFE RUTH PAYNE, STATES MET OSWALD AND WIFE SPRING OF SIXTYTHREE, THROUGH MUTUAL FRIEND, EVERETT GLOVER, DALLAS. STATES IN CONVERSATION WITH OSWALD, HE ADVISED WAS IN GUN CLUB IN RUSSIA. DESCRIBED OSWALD AS "MIXED UP" TYPE PERSON AND APPARENTLY HAD COMMUNIST IDEAS AS HE SUBSCRIBED TO DAILY WORKER. HAS NEVER SEEN OSWALD WITH RIFLE, HOWEVER HAD OBSERVED VARIOUS ARTICLES OF OSWALD-S IN GARAGE AT TWO FIVE ONE FIVE WEST FIFTH, IRVING, TEXAS,

INCLUDING BLANKET WRAPPED ARTICLE WHICH HE PRESUMED TO BE CAMPING EQUIPMENT. PAYNE IDENTIFIED A BLANKET IN POSSESSION OF DALLAS PD OFFICERS AS SAME ONE HE HAD PREVIOUSLY OBSERVED IN SAID GARAGE. HAS NOT SEEN OSWALD IN TWO WEEKS.

MRS. MARGUERITE CLAYTON OSWALD, FORT WORTH, TEXAS, MOTHER OF LEE HARVEY OSWALD, AND ROBERT LEE OSWALD, BROTHER OF LEE HARVEY OSWALD, DENTON, TEXAS, BOTH EXTENSIVELY INTERVIEWED BUT UNABLE TO PROVIDE ANY INFORMATION HELPFUL OR SPECIFICALLY PERTINENT TO OSWALD-S POSSIBLE RESPONSIBILITY OF ASSASSINATION OF PRESIDENT KENNEDY. THEY GAVE CONSIDERABLE BACKGROUND INFORMATION, THE IMPORTANT PORTIONS OF WHICH ARE ALREADY KNOWN TO THE BUREAU. BOTH SAID LAST CLOSE PERSONAL ASSOCIATION WITH OSWALD WAS DURING ABOUT OCT., SIXTYTWO, WHEN HE MOVED WITH HIS WIFE FROM FT. WORTH TO DALLAS, TEX. THEY HAD ONLY SPORADIC CORRESPONDENCE CONTACT WITH HIM FOLLOWING THAT TIME. NO INFO ILLICITED FROM THEM TO EFFECT OSWALD EVER HAD ANY FIREARMS WITH THE EXCEPTION OF SMALL INEXPENSIVE TWENTYTWO RIFLE WHICH HE HAD AS A BOY. HE EXHIBITED NO PARTICULAR INTEREST IN FIREARMS. BOTH DENY ANY KNOWLEDGE OF ANY MENTAL DIFFICULTIES, MOODINESS, VICIOUSNESS OR APPARENT FEELINGS ON THE PART OF OSWALD WHICH WOULD LEAD HIM TO ANY SUCH ACT AS THE SHOOTING OF THE PRESIDENT OR A POLICE OFFICER OR ANYONE ELSE. BOTH APPEARED ENTIRELY SINCERE, COOPERATIVE AND INCLINED TO BE AS HELPFUL AS POSSIBLE.
