RECORDS OF LOCATOR, HEADQUARTERS, U. S. MARINE CORPS, ARLINGTON ANNEX, FAILED TO REFLECT ANY RECORD PAST OR PRESENT FOR INDIVIDUAL WITH LAST NAME HIDELL. RECORDS REFLECT THAT ONE JOHN R. HEINDELL, MARINE SERIAL NUMBER ONE FIVE FOUR THREE EIGHT FIVE FIVE WAS ASSIGNED TO MARINE CORPS FIRST WING AIRCRAFT AUGUST THIRTEEN FIFTYEIGHT TO OCTOBER FIVE FIFTYEIGHT DURING TIME THAT LEE HARVEY OSWALD WAS ASSIGNED TO THIS UNIT.

HEINDELL DISCHARGED AND PERSONNEL RECORD LOCATED ST. LOUIS. NO IDENTIFIABLE DATA LOCATED FOR LIEUTENANT J. EVANS AS BEING IN ANY UNIT IN WHICH OSWALD WAS ATTACHED. FOR INFORMATION OF ST. LOUIS OSWALD IN APPLICATION FOR EMPLOYMENT DATED MAY NINE LAST WITH WILLIAM B. REILY AND COMPANY, INC., NEW ORLEANS, GAVE AS REFERENCE SERGEANT ROBERT H. HIDELL, ACTIVE DUTY, US.
