 ELECTRONICS COMPANY LIMITED, A SMALL PLANT AT RESEVOIR ADDRESS.

COMPANY MANUFACTURES ELECTRONIC WALL SWITCHES OF WHICH BASIC
 ELEMENTS OBTAINED FROM HUNT ELECTRONICS, DALLAS, TEXAS.

APPROXIMATELY TWO OR THREE WEEKS AGO LEWIS VISITED DALLAS WHERE

HIS CONTACTS ARE UNKNOWN TO [PEKAR.]

SHORTLY AFTER TRIP [PEKAR] OVERHEARD LEWIS-S SECRETARY, WHILE TYPING MENTION THE CAROUSEL, VEGAS, AND RUBY.

APPROXIMATELY TWO WEEKS AGO [PEKAR] SAW WOMAN RESEMBLING LOCAL PRESS PHOTO OF LEE HARVEY OSWALD-S WIFE STANDING OUTSIDE TRUMBULL PLANT AND SHORTLY THEREAFTER A SECOND WOMAN WHO RESEMBLED PRESS PHOTO OF OSWALD-S MOTHER ENTERED [HIS] ELECTRONICS COMPANY OFFICE AND SPOKE TO LEWIS-S SECRETARY.

SECOND WOMAN HAD SMALL BABY IN ARMS.

[PEKAR] SAW NOTHING MORE OF EITHER WOMAN AND AT NO TIME HEARD ANY MENTION OF ANY PLOT TO ASSASSINATE PRESIDENT KENNEDY OR ANYTHING AGAINST BEST INTERESTS OF UNITED STATES.

[PEKAR] SAW THE TWO WOMEN ONLY VERY BRIEFLY BUT SAID THAT AFTER TWO DAYS OF THINKING OF PRESIDENT KENNEDY-S ASSASSINATION AND OF LOOKING AT LOCAL PRESS PHOTO OF OSWALD-S WIFE AND MOTHER [HE] FELT THEY WERE POSSIBLY IDENTICAL WITH THE TWO WOMEN [HE] SAW AT THE PLANT.
