A search of the indices of the Dallas Office failed to locate any reference to Lee Harvey Oswald in the files captioned "Fair Play for Cuba Committee" or "Funds Transmitted to Residents of Russia" which had not previously been sent to FBI Headquarters (FBIHQ).

With regards to your request for information from the files of the New Orleans Office of the FBI, please be advised that in order to respond completely and thoroughly to your request it will be necessary for the New Orleans Office to forward to FBIHQ, for processing pursuant to the FOIPA, the investigative files maintained by that office. When the processing of the New Orleans files is completed, any documents which are responsive to your request will be forwarded to you.
