Present Xeroxing rates are as follows:

Full-size copies: 2.7¢ per page for copies 1-10; 2.0¢ thereafter (i.e., for more than 11 copies of the same original page)

Two-on-one: 3.6¢ per exposure (i.e., per 2 original pages) for the first copy; 2.8¢ for copies 2-10 of the same original; thereafter 2.0¢.

These originals are quite sharp, so 2-on-1 or even 4-on-1 should be quite legible.
