Thanks for your letter of the 21st.

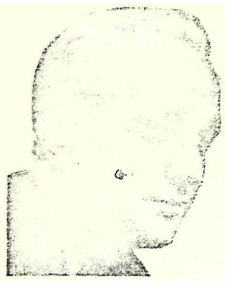
This book has, surprisingly, very little on Carlos B. himself. No index reference to Fernie.

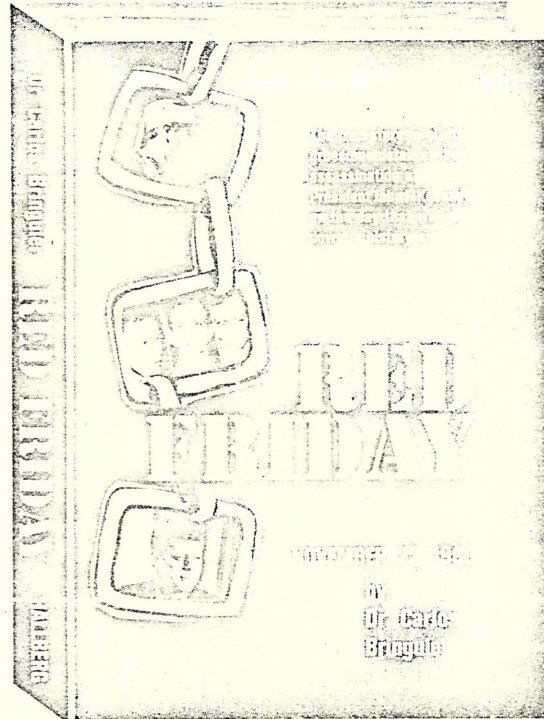
