As a result of LEE HARVEY OSWALD's reported affiliation with the FPCC, the organization publicly linked to the assassination of President KENNEDY. On 12/28/63, the FPCC moved out of its offices at 799 Broadway, NYC. Some FPCC property reportedly stored at Workers World Party Headquarters, NYC, and FPCC mailing list in TED LEE's possession. NYC newspaper reports regarding dissolution of the FPCC set out. On 4/13/64, informants advised that there had not been any FPCC activity in months and that the organization was dissolved and dead.
