The annotations are amusing, with a concluding summary, "Hardy is trying to show the outlook of the people of the Victorian period upon the moral duties of men and women. The people allowed men freedom to behave as they saw fit; whereas they demanded chastity in the women." This book was unquestionably passed on to Jack Kennedy by Joe at Choate and used by him. Some of the underlinings and markings are probably in the hand of John F. Kennedy: "Fighting Liberal" (the autobiography of Senator George W. Norris), Macmillan, New York, 1945, first edition (slightly worn), with extensive page markings (mostly in colored pencil or crayon) in the hand of John F. Kennedy, and the initials "J. K." are written in blue-pencil on the front fly-leaf. This volume was probably used in the preparation of a paper or speech. There are inserted a typescript of a statement by Norris, marked in red-pencil by Kennedy, "Norris — 1942!," and two Senate Memorandum sheets with several holograph notations, referring to sections of the book. In both volumes, many pages are marked by the insertion of tiny slips of paper, a habit of John F. Kennedy.
