

Mark Lone on Barry Gray 19 July 1964  
11:20 pm  
Show WMCA - Sam missed  
first 15 minutes - played tape recording  
telephone conversation Helen Markheim "sole  
witness" to Tippit murder. Tape played  
for "first time" not same as tape heard  
Town Hall meeting Febr. 1964 (or March?)  
but played in entirety. Was said to have  
been heard on 18 July 1964 by Warren  
Commission, to which Mark Lone had  
mailed it.

In discussion, Lone  
indicated that Mrs. Markheim had  
identified Oswald in a line-up of  
three in Dallas Police Station. He was  
wearing gray jacket and dark trousers - which  
Miss M. had told police at scene Tippit killing  
were worn by the killer - although Oswald  
was attired when arrested in theatre right  
after the Tippit shooting the same dark  
brown shirt in which he left the Book

Depository Bldg.

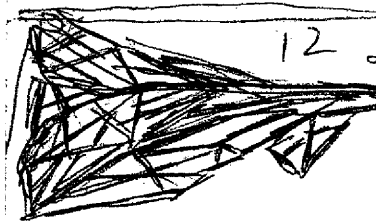
It is surprising that neither Lone,  
Buchanan or Jaesten mentioned Markheim's  
identification of Oswald.

Entry wound, story later changed.  
Toesten says, prepostems expert doctor  
failed see wound in back.

"Rode of horses" have come out in Europe.  
Tape of Monk here, problem of  
termining - Oswald drinking soda - on that  
alone, impossible for Oswald to be  
assassin.

Bus - taxi - walking - running -  
Tape of Mrs Roberts - Homekeeper -  
get a short coat and went to bus stop  
- Did he pick up postal? Toesten  
says, after unvesting to Mrs Johnson  
- Landlady - Oswald had no gun  
in his room.



Gas re encounter with Tuzipatt. Tape  
of Don Bonafee, H Trib reporter,  
why did one stop to talk to the  
other. Helen Marklin, solo writer,  
says Stooky, bushy-haired.

Witnesses in an office a block away  
saw a man running from scene  
Tuzipatt, reloading his revolver

"Foscunator Conicidum" of Warren  
Reynolds, 2 mos later shot in  
lead - did not die - suspect  
picked up - released - girl  
jumps herself - Copri  
pants - had worked for J Ruby.

Police cars following trap - to Texas  
theater, arrested LHO. Tape of  
Osmond telephone interview on  
monumental mistakes of State Dept  
DCIA, pushing Cuba -> Communism

(Very literate, good vocabulary,  
confident & informed) -

Was it only a pose? Mother says yes,  
says she has written evidence he was  
a Gov't agent. (Tape) Gov't helped  
him every way possible - even  
when he returned, no pressure  
on him, even for desertion from  
Marines (AWOL).

CIA denies he was agent, laundry -  
Gov't must turn in bedrooms, reading  
& radios - sometimes watched  
TV - was pleasant but never  
committed, gave opinions

Tape - nothing unusual about  
Osmond (fellow-tenant?)

Marina (good English) (tape) - says  
he wanted kill Nixon in Feb or  
April 1963 & tried kill  
Sen Walker

Osw mother insists FBI knew about  
RUBY in advance - insists showed  
her photo of Ruby day before - 6:30 pm  
on Nov 23 - at Exec. Inn -

FBI says she is mistaken - Ruby  
says did not know Osw, there  
was no conspiracy

Tape of Ruby "how I loved my President"  
innocence itself, sitting in jail -  
self-pity & self-righteousness -  
tears - "police dept were my  
friends - I never felt so  
much at ease in a city - I  
left Chicago because there was  
so much culture here"

Tape, Belli "We have got to  
rely on Chief Justice & the  
Commission."

Tape, Warren - for funeral oration  
"forces of hatred & malevolence"
