The ABNP index, as originally prepared, had no entries for CD 1066, Gemberling's report dated 5 28 64.

Since the time it was prepared, the synopsis and table of contents of CD 1066 have arrived.

CD 1066 has been reviewed and various new entries have been typed into the ABNP index

The attached sheets contain these new entries. (Suggestion: they can be cut up and pasted in where they belong).

Where new entries have been added, the page counts for each subject have been affected. (This refers to the subject list at the beginning of the index. After the subject, there are two numbers: the first gives the number of starred (*) pages, available but not published. These starred pages are probably title pages, and will not be ordered from the archives. The second gives the number of pages which contain printed matter, and which will be ordered. (SEE note #12, on notes and comments, at the beginning).

What follows is a list of new page counts, where the count has been affected by material from CD 1066.
