Dear Sylvia,

Enclosed find a carbon copy of notes I have just written up on a meeting tonight with Allen Dulles, who is on a student program here at UCLA. They are rather self explanatory. I simply do not have the time to type and edit this material into a perfect final form, but I wanted to record my impressions while they are fresh. Once again, I apologize for the "diary" tone, but this is the way I write, and, especially in this case, I made these notes more for my own memory's sake, than for important research use. Dulles didn't say anything---he just denied and lied in front of a whole group of people.

When I returned to my place at 8:30, my girlfriend Judy told me that she had goofed by answering the phone when you called. Because I frequently get long distance calls from other people and my folks in New York, who is not supposed to answer my ~~XXX~~ phone unless I ring twice first. This was her fault, and I'm sorry she wasted a dollar of yours. Whenever you wish to call, feel free to call station-to-station, and I'm sure this won't happen again.

Incidentally, I frequently keep very weird hours, and don't come home until the library closes. For that reason, one of the best ways to reach me is through my girl friend. Her phone number is 4771488, and I usually call her from the library. She lives a block away from me, so she can even run over to my place and put messages on the door if something important turns up and you can't reach me.

Judy tells me that she thinks that she might have given you the impression that she lives over here; she doesn't. (Not that I object, in principle, to such communal living, but most women I have met seem to hold this ~~XXX~~ view, and I'd end up getting married while I'm still too young.) Anyway, in answer to your questions.....

Enclosed find a list. Note that all pictures were not "copied". This is because ~~KK~~ there is plenty of overlap. I only copied enough necessary to form of continuous sequence of the landscape from all the positions. (Copying Z-2, ~~Z~~Z-3, for example, would add nothing to what is known by viewing Z-1 and Z-4). The only one I copied and which you haven't received is Z-4. "C" following the number indicated a copy was made (that is a "copy negative" was made). I kept the original numbers, however, for the sake of accurate documentation.

~~XXX~~ I think these pictures are equivalent to a trip to Dealey Plaza. They are excellent for making judgements about what various people must have seen, could not have seen, and possibly have seen. Much of my "bluffing" in the Mockman and Hill phone calls was based on my conviction that there was indeed a man shooting from behind the wall, and that these pictures convinced ~~me~~ at least, that many people on Dealey Plaza had to see this.

I'll find out from Lillian when the pictures were taken. I may hear the tape sent out here this Saturday. It all depends on how much schoolwork I have. Things are calming down a bit, from my own point of view, though the discussion of what constitutes "blood money"; and what is "rightful earnings" will probably always exist in this case.
