Dear Mr. McDade,

Red Roses of Dallas by Nerin Gun is an account of the events of 11/22/63 and the evidence, eyewitnesses, and official theory. I have the French edition, published in 1964 by Rene Julliard, Paris. I have heard that there is an English-language edition but have never seen it.

The Wounded Land by Hans Habe, published by Coward-McCann in 1964 (translated from the German) devotes at least three chapters to the events of 11/22/63 and the evidence, the main theme of the book being a "journey through a divided America." It is a borderline case but probably should be included in a bibliography.

Lee Harvey Oswald by Michael Hastings is a play that deals with Oswald's relationships with his wife and his mother (and their relationship with each other), and with his possible motivation. There is also an introduction by Hastings, as I recall it, expressing his personal misgivings about the official findings. It should be included, I think.

Dallas Public and Private by Warren Leslie is a valuable source book on Dallas, its power structure, political passions, and major personalities, in the context of the period immediately before and after the assassination. It probably should be included.

Oswald by Kerry Thornley deals with Oswald's psychological traits, possible motives, and service in the Marines together with the author; also included is a transcript of Thornley's testimony before the Warren Commission.

I regret that I am not familiar with the other publications flagged by a question mark. However, I can supply you with a number of items not included at all in the Spencer/Hurst bibliography:
