Paul Hoch finished his PhD dissertation and was interested in getting a gook done on Oswald the last time we spoke, but we have been out of touch for some months. I will be writing him today also.

Given that this year will be the 10th anniversary of the assassination both Paul and I felt that there would be pieces published backing the official version and that the critics should prepare their own rehash. Paul said that he would try to put together some ideas, and I agreed to help although I indicated that I could not do the primary writing. We were thinking along the lines of explication of a serious of still-unanswered questions and also a review of material which has surfaced through release of archives materials, Wecht's viewing of the X-rays and photos, the Justice Dept. Report on the autopsy materials (Fisher, \$t.al.).

Speaking of Cyril, the last time I heard from him, which was some months ago, he was still planning to do a scientific monograph. I am getting a bit skeptical as the l year anniversary of his visit to the archives approaches. There was an article in TRUE magazine which covered about the same amount of ground as the one in the NY Times.

As usual, I am still inactive and devote most of my time to things other than work connected with the assassination. I still give occasional slide presentations, typically to friends in an informal setting.

I am hoping to get a dissertation underway and finished early next year. Then I will probably quit my job and take off for some travels around the country and the rest of the world. I had a fine trip to Europe last Sept. and would like to go back again. I have been saving up so all I need is the time and freedom. I trust that you have managed some vacation time yourself.

Best wishes for a nice summer. I hope I can get a chance to see New York again (its been 10 years) and perhaps then I can buy you dinner.
