Perhaps you remember me--some years back, I corresponded with you about the assassination of President Kennedy and your work in uncovering the real story. This letter, however, deals with a different matter, and any leads you can give me will be most greatly appreciated.

To put it simply, I am now one of the "6%" you hear about when the monthly unemployment statistics are reported. (Actually, I have a part-time job in a bakery, but that just about pays for food.) As the enclosed resume shows, I was for two years an employee of the Tompkins County (Ithaca) Department of Social Services. I resigned in boredom and disgust this spring—there is nothing more inefficient than a welfare department. I took a gamble with a local businessman and lost, and have since then been working only intermittently at temporary jobs.

I do not think I am being arrogant when I say that I have a well-developed writing ability. I would like very much to be able to work as a writer, but positions in journalism are all but closed these days to anyone without formal journalistic training. And the possibilities of surviving as a free-lance writer seem very slight.

So...why am I telling you all this? If I remember correctly, you work for the United Nations as a researcher and writer. I was wondering whether there might be any job possibilities at the U.N. for someone with my background. I wrote to the U.S. Mission to the United Nations over a month ago, but have still received no response. Needless to say, I'm not really expecting miracles, but I feel this request is worth the try. If you need any further information, I shall be happy to supply it.

I hope all is well with you. I'd be interested to know whether you are still researching the Kennedy case; specifically, do you believe that there might be some connection between Dallas and Watergate (especially concerning Gordon Liddy and E. Howard Hunt)? I've heard this theory from several sources, although I must say that the documentation I have seen so far is at best flimsy.

Again, any information you can provide in relation to the above request will be most welcome.
