The evidence of the 3 nurses at Parkland and Capt Stevenson's withdrawal of the "battleship" 14 hours before Kennedy arrived, are in the 26 volumes, but not apparently anywhere else. Yet both are important.

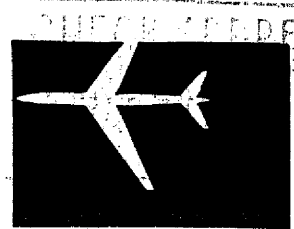
