L have at last obtained a copy of the second edition of your magnum opus. 'I had long assumed that it was out of print, and unobtainable. Now I am reading it from cover to cover with the great advantage I can underline the pssages, which seem significant to me. I am amazed at the care with which you read the Warren Report and the 26 volumes of evidence; you seem to miss nothing -- or almost nothing!

None the less much has emerged in the intervening 15 years. and there will be much that is new in my book, of which the whole as is chapters are in draft. Thus you have nothing -- or scarcely anything on the parts played by the OGPU, the Mania and the Texan Cabal --a polite phrase chosen to cover the gang headed by Lyndon Johnson, which will not cause as much offense as mentioning LBJ himself.


