Dear Ms. Meagher:

I am sending you a copy of the prospectus for my assassination book, and will appreciate hearing from you if you have any thoughts on who might be interested in publishing it. I am also enclosing a copy of a "refused to sign" fingerprint card that I found in the National Archives. This card was supposedly forwarded from Inspector Kelley to Chief Rowley of the Secret Service on December 2. The apparent alterations on this card---and on two "filled out" versions that the Secret Service also had---furnish some material for my "identity" discussion in chapter 4.

Many thanks for the CD 1245 material on the "epileptic seizure." Apart from the unresolved conspiratorial implications of this episode, it just boggles the mind to realize that the FBI did absolutely nothing to investigate the matter until a worried citizen called them in May of 1964; kind of reminds me of your analysis of the belated "mark on the cubb" investigation.

When I spoke with you I forgot that I had been wanting to ask you if you have anything in your files on the deaths of Teresa Norton or Karen Bennett Carlin. You mention in Accessories that Norton was murdered in August 1964; the London Times and a couple of other unreliable sources include Carlin among the "mysterious deaths." Since I cannot find anything on Norton as a Ruby employee---nor on Carlin after her second Warren Commission appearance---I wonder if Carlin changed her name to Norton and was the victim in question. In my book I cite evidence to question the authenticity of Carlin's phone call to Ruby on November 24, and also indications that she feared for her life at the hands of Pat Kirkwood, the Ruby associate and proprietor of The Cellar where the Secret Service agents met on assassination eve. I find many indications of post-assassination intimidation of Ruby associates (beyond the known mysterious deaths) and I would hope to find out whether Karen Bennett Carlin may have been the victim of the ultimate intimidation.

Thank you again for sharing your vast experience in this subject with a relative neophyte. I hope the book that I ultimately publish will be worthy enough that you will not be terribly embarrassed to have me publicly acknowledge your influence.








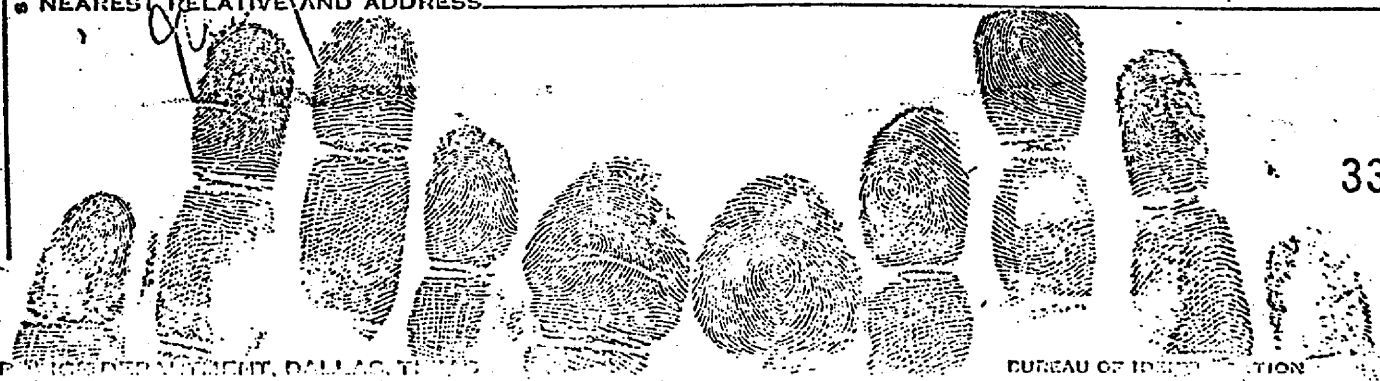
