Dear Sylvia:

Last week I mailed you a package that came from Ted Gandolfo. When it arrived at my house, it was all-to-pieces... I just put it in another and stronger envelope and mailed it to you. I should bring you up-to-date on the saga of Gandolfo vs. Mary Ferrell.

I tried for about three days after you sent me the order blank to find someone who would allow me to give them the money and have them order the book to be sent to their house... Everybody acted so stupidly about it that I decided to try it on my own. I typed out an order blank and sent it to Ted, asking that two copies be sent to my house. Two days later, the man called me and wanted to know how I knew about it. I told him a friend of mine in California, Ms. Zanone, had called me to ask if I had heard about it. Somebody in New York or Washington sent, or wrote to her, telling her it was coming out. He wanted to know how to call her because he wanted to try to sell her some of his tapes! I said she was now living in the Bay area with a cousin. I would have to get her exact address. He wanted to know why I ordered two copies, and I explained that I buy at least two copies of everything about the assassination.

He spent about an hour trying to sell me his tapes which are "the best things you have ever heard." I told him I had to go and would "think about it." A few days later, I received a letter from Dick Sprague (Hartsdale Sprague) telling me he was a friend of Ted Gandolfo's and Ted was sending him an advance copy of the book in the next few days. Then, last week I received the two packages. Believe me, Sylvia, my package was literally all-to-pieces. Somebody had put the last few pages back into the package on top of the others, wrapped the remains of the envelope back around it and tied it with a string... I sent you the better wrapped of the two.

I am sorry that you didn't receive a better book, better wrapped -- but I am only responsible for the outer wrapping of this ridiculous piece of trash, as far as I'm concerned. So much could be said about their shortcomings, but he has managed to do such a mess with it.
